Notes:

1. The adjusted rate is equal to the blended rate plus the greater of the underserved areas rate or the new facility rate. The greater of the adjusted rate or one percent is applied to all workload measures except FTES. This rate may be adjusted to insure that the district receives at least 150 students in the student services category of program based funding, as well as an increase equivalent to the state supported increase in gross square footage in the maintenance & operations category.
2. The adjusted rate with minimums is equal to the rate necessary to insure the district receives at least the greater of one percent or 100 FTES. This rate is applied only to FTES.
3. This rate would be added to the adjusted rates, to the extent possible, if funds are available after the lesser of adjusted rates or actual workload are fully funded for all districts.
