The Board of Governors of the California Community Colleges, by statute, provides leadership and policy direction in the continuing development of the California Community Colleges system. Among its charges are establishing minimum academic and personnel standards; evaluating and reporting on the fiscal and educational effectiveness of the 72 districts; conducting research and providing appropriate information services; and administering fiscal support programs (both operational and capital outlay).

The 17-member board, appointed by the governor, includes 12 public members (two of whom must be current or former elected members of local boards); one voting and one non-voting student member currently enrolled in a community college; two voting tenured faculty members; and one voting classified staff member.

The work of the board is supported by the staff of the California Community Colleges Chancellor’s Office.

**Academic Record Symbols and Grade Point Average; Withdrawal (Rhonda Mohr)** **Item 2.6**  
This item is a second reading of proposed regulations amending California Code of Regulations, title 5, section 55023, *Academic Record Symbols and Grade Point Average* and section 55024, *Withdrawal*. The purpose of the revision of these regulations is to add a new non-evaluative symbol, Excused Withdrawal (EW), in order to reflect that a student's withdrawal from a course was compelled by circumstances beyond his or her control.

**Appointment of Patrick Mulvaney to the Board of Directors of the Foundation for California Community Colleges (Keetha Mills)** **Item 2.7**

This item requests the appointment of a new Board member, filling the role of public member, to the Board of Directors of the Foundation for California Community Colleges (Foundation) for a four-year term.

## **First Reading**

**Credit Certificates (Laura Hope)** **Item 3.1**

This item is a first reading of proposed regulations amending California Code of Regulations, title 5, section 55070, *Credit Certificates*. The purpose of the revision is to align title 5 provisions with federal financial aid eligibility regulations by amending the minimum unit requirements for credit certificates.

**Approved Plan Required; Requirements of the Plan; Work Experience Credit (Alice Perez)** **Item 3.2**

This item is a first reading of proposed regulations amending California Code of Regulations, title 5, section 55250, *Approved Plan Required*, Section 55251, *Requirements of the Plan*, and section 55256.5, *Work Experience Credit*. The purpose of the revision is to transfer authority from the Chancellor's Office to local districts to approve Cooperative Work Experience (CWE) plans and courses to better respond to emerging community and workforce needs. Additionally, the proposed amendments would allow the awarding of units in .5 increments.

**Nonresident Tuition Exemption Implementation (Marc LeForestier)** **Item 3.3**

This item is a first reading of proposed regulations amending California Code of Regulations, title 5, section 54045.5, *Nonresident Tuition Exemption Implementation*. The purpose of the revision is to conform our regulations to recent changes in the law following passage of Senate Bill 68 (2017).
