Please find attached the 2014-15 Proposition 39 allocations for energy projects totaling \$31.6 million.

The Proposition 39 amount of \$37.5 million included in the 2014-15 budget for community colleges is \$1.5 million less than what was previously included in the Governor's Budget. Consequently, the \$31.6 million allocated for energy projects is less than what was previously estimated and this is reflected in lower allocations for each district.

Many districts have submitted "Form B" applications exceeding their revised allocation amounts. In these cases, districts will either need to fund the difference locally or revise the projects and the "Form B" applications to reflect the lower allocations.

Please work with your utility representative and Newcomb Anderson McCormick to make any necessary revisions to projects as soon as possible. Our goal is still to release the bulk of the Proposition 39 funds in July and August 2014.
