SYNOPSIS: The California Community Colleges will administer leadership activities for AB 86 Adult Education Consortium Planning Grants, guided by the joint oversight partnership between the California Community Colleges, Chancellor's Office and California Department of Education. One-time funds totaling \$2,500,000 from the California Community Colleges, Chancellor's Office AB 86 funding is available for the continuation of leadership activities. These funds must be contracted with a community college district; therefore, the California Community Colleges, Chancellor's Office is soliciting interest by districts that are qualified and may wish to serve as fiscal agent for this project. The contract would be for a period of up to two years (with a maximum end date of June 30, 2015). Time is of the essence for continuing the implementation of this regional planning effort; therefore, interested districts must have demonstrated experience in administering similar projects with multiple stakeholders and contractors involved. The fiscal agent for this project will receive an administrative fee of five (5) percent of the total available budget.
