## GENERAL INFORMATION AND BACKGROUND OF RISING SCHOLARS NETWORK:

Serving incarcerated and formerly incarcerated students is core to the California Community Colleges' mission, critical to the Chancellor's DEI Call to Action, and closely aligns with the [Vision for Success](#) goal to reduce equity gaps among traditionally underrepresented student groups. The California Community Colleges' Rising Scholars programs now reach and serve almost 20,000 justice-involved students both on campus and in prisons, jails, and juvenile detention centers throughout the state. The Chancellor's Office has built a strong foundation to serve this student population by providing quality technical assistance.

In 2018, the State of California committed to serving incarcerated and formerly incarcerated students through one-time funding of \$5 million, resulting in 44 grants to California Community Colleges. In 2021, the State furthered its commitment to serving this population of students with a \$10 million ongoing allocation in the 2021 State Budget Act and the passage of [Assembly Bill 417](#) (McCarty, 2021), which established the Rising Scholars Network as a categorically funded program.

## OBJECTIVES

The Rising Scholars Network is just one of many initiatives aligned with the *Vision for Success* goals. This program's overarching objective is to expand the number of justice-involved students participating and succeeding in the community colleges. To accomplish this, successful grantees must focus relentlessly on the following *Vision* goals:

1. Increase the number of California Community College students annually who acquire associate degrees, credentials, certificates, or specific skill sets that prepare them for an in-demand job;
2. Increase the number of California Community College students transferring annually to a University of California (UC), the California State University (CSU) or four-year independent colleges/universities;
3. Decrease the average number of units accumulated by California Community College students earning associate degrees;
4. Reduce equity gaps across all of the above measures through faster improvements among traditionally underrepresented student groups.

## FUNDING

The Chancellor's Office will distribute the funds through an application process.

Funding criteria are derived from AB 417, the *Vision for Success*, and the Guiding Principles approved in 2020 by the Chancellor's Office Advisory Committee for the Rising Scholars Network.

The Chancellor's Office anticipates awarding up to 50 California Community Colleges with a minimum of \$100,000 per year for three years, contingent upon State of California budget allocations. In year three, the Chancellor's Office will conduct a comprehensive review of the application criteria and outcomes and will open a new funding cycle. In the next three-year cycle, minimum requirements for number of students, credit enrollment and number of degrees may increase. The next funding cycle may also base funding decisions, in whole or in part, on student demographic and outcome data



collected from Chancellor's Office Management Information System (COMIS), including but not limited to, enrollment, persistence or retention, certificate and degree attainment, and completion or transfer.

## **ELIGIBILITY REQUIREMENTS**

All California Community Colleges are eligible to apply. All applications recommended for approval shall have or obtain approval from applicant's Board of Trustees. In the event the application timeline does not allow for Board approval, a signed letter from the District/College President is an acceptable substitute.

One or more colleges within a district may choose to submit an application as a district. District applicants will be eligible for one grant just as if they were a single college applicant, but they will be able to respond to the questions in the application based on practices and data from any college in the collaboration or by combining practices and data from the colleges in the collaboration. Colleges may apply through their district or as an individual college applicant, but not both.

## **APPLICATION DETAILS**

The application must be submitted on or before **Monday, March 21, 2022 by 5:00 pm PST**. Due to remote work related to the COVID-19 pandemic, mailed, emailed or faxed copies of the application will not be accepted. Only applications submitted via the Nova system with a time stamp of 5:00 pm PST or earlier will be accepted.

The application differentiates between those that received a reentry grant in 2019 and those that did not. In addition, this application is divided into two categories:

- (1) Programs that serve students in prison, and
- (2) Programs that serve students on campus and/or jail and/or juvenile detention centers.

**Applicants must choose only one category even if both populations are served.** However, applicants selected for funding may use their Rising Scholars Network funds to serve students in both categories. Applicants that make this choice will be expected to report on outcomes in both categories.

## **PERFORMANCE PERIOD**

The successfully awarded grantees will be awarded in 2022 annually for a total of three years. The actual start date is subject to change. The grant is contingent upon the availability of funds and acceptable performance. There will be no extensions to the performance period.

Applicants that fail to report a known or suspected problem with the RFA, or fail to seek clarification and/or correction of the RFA, shall submit a proposal at their own risk. In addition, if awarded the grant, the successful applicant shall not be entitled to additional compensation for any additional work caused by such problem, including any ambiguity, conflict, discrepancy, omission, or error.

## APPEALS PROCESS

Applicants who wish to appeal a grant award decision must submit a form via email to Dean LeBaron Woodyard at [LWoodyar@cccco.edu](mailto:LWoodyar@cccco.edu) and Marissa Anderson at [Manderson@cccco.edu](mailto:Manderson@cccco.edu). The form, with a signature by the authorized person, must be received no later than **5:00 pm PST on Monday, April 11, 2022**. Only e-mailed forms will be accepted. The final decision will be provided in writing within 30 days from the date that appeals are due. The CCCCO's decision shall be the final administrative action afforded the appeal.

Appeals shall be limited to the grounds that the Selection Committee failed to correctly follow the specified processes for reviewing the application. The appellant must file an appeal form, including the issue(s) in dispute, the legal authority or other basis for the appeal position, and the remedy sought. Incomplete or late appeals will not be considered. The appellant may not supply any new information that was not contained in the original application.

The Vice Chancellor shall:

1. review all appeal submissions
2. disqualify appeal submissions that did not follow submission procedures
3. render a final decision, and
4. notify appellant of final decision within thirty (30) calendar days of the date of appeal receipt.



## RISING SCHOLARS NETWORK 2022-2025 FUNDING APPLICATION

### **General Standards and General Information**

Please read all directions thoroughly before beginning.

Applicant must choose between submitting an application for prison students (state or federal) **OR** jail, juvenile and/or on-campus, even if applicant serves both populations.

This Application is divided into two categories:

- (1) Programs that serve students in prison, and
- (2) Programs that serve students on campus and/or jail and/or juvenile detention centers.

**Applicants must choose only one category even if both populations are served.** However, applicants selected for funding may use their Rising Scholars funds to serve students in both categories. Applicants that make this choice will be expected to report on outcomes in both categories.

Please note that “Rising Scholars students” are students who are currently incarcerated or detained, or students with a prior adult conviction or juvenile adjudication. Students not incarcerated or detained, or who don’t themselves have a prior conviction or adjudication, should not be counted as Rising Scholars students for purposes of this application.

A “Rising Scholars program” is any program offered by the college explicitly to support incarcerated or formerly incarcerated students, whether or not the college received a 2019 Reentry Grant. The college does not need to use the name “Rising Scholars” to be considered to have a “Rising Scholar program” for purposes of this application, so long as incarcerated and/or formerly incarcerated students are explicitly the recipients of the program services.

### **General Standards:**

This application has two categories (prison and campus/jail/juvenile) and each category has a set of general standards, below. Applicants must select one category and respond to all questions in their selected category. The Chancellor’s Office may use COMIS to confirm applicant’s responses to the general standards questions below.

**Category 1. Prison:** Applicant serves students incarcerated in the California Department of Corrections and Rehabilitation (CDCR) and/or Federal Bureau of Prisons (BOP).

## SECTION F: SCORING RUBRIC

The following rubric outlines the parameters and point values that will be used as a basis for determining which proposed Rising Scholars Network programs will be recommended to the Board of Governors for funding.

**General Standards:** Applicants will receive 10 points if they confirm compliance with all General Standards in their chosen category (3 questions for category 1 prison, or two questions for category 2 campus/jail/juvenile.) Applicants will be scored for either category 1 or category 2, not both.

**General Information:** The questions in the General Information section will not be scored.

**Sections A – D:** 80 points will be available in Sections A and B. Applicants that received a 2019 Reentry Grant will be awarded one point for each “yes” response, for a total of 40 possible points in section A and 40 possible points in section B. Applicants that did not have a 2019 Reentry Grant will be awarded two points for each “yes” response, for a total of 40 possible points in section A and 40 possible points in section B. All applications will be reviewed and scored in one combined applicant pool. Responses to Section C and D will not be used to determine which applications will be recommended to the Board of Governors for funding.

### TIE BREAKER

In the event of a tie, applicants will be ranked based on the following criteria as verified in the Chancellor’s Office Management Information System (COMIS):

1. Priority will be given first to colleges that serve students in all categories.

If no Applicant checks all categories, priority will be given to Applicants that check 3 of the 4 categories.



2. If a further tiebreaker is needed, priority will be given to applicants with the highest percentage of Rising Scholars students (SG04 and SG15) who were awarded degrees or certificates in 2019-20 and in 2020-21. Data will be pulled from COMIS for 2019-20 and 2020-21 and averaged over the two years.

Once scoring is complete, proposals are ranked by the Chancellor's Office and categorized as:

1. Funded (contingent on Board of Governor's approval);
2. Eligible but not funded (minimum 63 pts but insufficient rank);
3. Not eligible (below 63 pts); and,
4. Not scored (rejected during preliminary review).

Each of the selected Applicants may receive minimum base funding of \$100,000 per year for 3 years, assuming continued state budget allocations. Applicants that complete Section C, Funding Tiers, may be eligible for additional funding as set out below. There are 15 criteria for additional funding in Section C. Applicants may receive one point for each criterion for which they can confirm compliance, up to a total of 15 points. A maximum of one point may be awarded for each criterion, whether applicant confirms compliance in one year or both years. The additional funding may be allocated as follows:
