STATE AND NATIONAL GUIDANCE/EXECUTIVE ORDERS

Gov. Gavin Newsom today gave an update on the state's response to the COVID-19 pandemic. Among the highlights:

- Newsom and State Superintendent of Instruction Tony Thurmond said schools will not reopen for the remainder of the school year and will instead focus on distance learning. The governor [announced an agreement](#) between teachers, classified employees and school system management to support student instruction during that time. [Read the full framework here](#). Thurmond said "it is important schools continue to do what they're doing...so our students can continue to get an education but done in a way that remains safe." He shared similar thoughts in a [letter released Tuesday](#).
- Gov. Newsom also announced a partnership with Google that will provide 100,000 points of access to improve Wi-Fi and broadband service for a minimum of three months free throughout California. Google will also make thousands of Chrome Books available. The California Department of Education will be distributing these resources, prioritizing rural communities.
- In 48 hours, more than 34,000 people have signed up for the newly-established [California Health Corps](#).

The governor on Tuesday [announced a campaign](#) to protect the health and well-being of older Californians during the pandemic. The campaign encourages all of us to check in on older family members and neighbors with a call, text message or a socially-distant knock on the door.

Also on Tuesday, the governor said there's no time certain for state lawmakers to come back to session. The Legislature voted last month to break until mid-April but Newsom said that timeframe is fluid.

Gov. Newsom is holding daily news conferences every day this week at noon. All news conferences will be streamed live on his [Twitter page](#) and the [California Governor Facebook page](#).

Yolo County today [officially extended its stay-at-home order](#) until May 1. Sacramento County is [expected to do the same](#).

Sacramento County also announced [one-third of county coronavirus cases](#) are connected to church gatherings, as Vice President Mike Pence said [Americans should not attend church services](#) of more than 10 people.
