

## STATE AND NATIONAL GUIDANCE/EXECUTIVE ORDERS/NEWS

Gov. Gavin Newsom today gave an update on the state's response to the COVID-19 pandemic. (All daily news conferences are streamed live at noon on his [Twitter page](#) and the [California Governor Facebook page](#).) You can find more information on [California's COVID-19 website](#).

Among the headlines from today's update:

- [California is working with Oregon and Washington](#) on a shared vision for reopening the states' economies and controlling COVID-19 in the future. The governor said he will unveil more information on Tuesday as to when the statewide state-at-home order could be lifted.
- [California is launching a \\$42 million effort](#) to invest in building supports for 86,500 vulnerable children across the state, including 59,000 children in foster care. The money will provide virtual outreach and more resources, support and capacity to reach the most vulnerable among them.
- The state has 22,348 positive cases of COVID-19 but the governor says the curve is bending because of early efforts, including practicing social distancing.

[Gov. Newsom on Friday announced](#) the release of \$100 million to support child care services, and to support child care providers who are stepping up to serve essential infrastructure workers and vulnerable populations and their children during this critical time. Of the funding, \$50 million will go to the California Department of Education to be used to pay for up to 20,000 limited-term additional state-subsidized slots for child care.

The U.S. Department of Treasury said today [80 million Americans will get their relief checks](#) this week. Payments started going out on Friday. The IRS will have a [new web portal](#) set up later this week where people can track the status of their payments.

The [Trump administration is still hopeful](#) the country could reopen by May 1 but experts, including Dr. Fauci, say a number of factors need to be considered before that can happen.
