## STATE AND NATIONAL GUIDANCE/EXECUTIVE ORDERS/NEWS

Gov. Gavin Newsom today gave an update on the state's response to the COVID-19 pandemic. (All daily news conferences are streamed *live at noon* on his [Twitter page](#) and the [California Governor Facebook page](#).) You can find more information on [California's COVID-19 website](#).

The [governor and First Partner Jennifer Siebel Newsom today](#) announced partnerships to support distance learning and bridge the digital divide for the nearly one in five students in California who lack consistent access to computers and the internet. The partnerships promise:

- Commitments from companies, business leaders, and philanthropists to provide internet access for hundreds of thousands of households and laptops, Chromebooks, and tablets for more than 70,000 students;
- The California Public Utilities Commission will make \$30 million available to help school districts ensure that families have Internet access and computing devices for distance learning;
- The California State Transportation Agency will partner with the City of Sacramento to convert and deploy seven transit buses to be used as super hotspots.

The governor also said he would provide an update on Wednesday on the timeline to reopen the state.

[Gov. Newsom on Saturday announced progress](#) that the state and counties have made together in providing safe isolation capacity to protect people experiencing homelessness from COVID-19. The effort has secured nearly 11,000 hotel and motel rooms to provide safe isolation areas for this vulnerable group.

The governor on Friday [signed an executive order](#) that allows for temporary waivers to certain foster youth programs to ensure continuity of care in response to the COVID-19 pandemic.

The [Senate on Tuesday could take up a \\$450 billion coronavirus aid package](#) that would boost a small business loan program that's out of money, help for hospitals and virus testing. Both President Trump and lawmakers have said they are close to a deal.

As many countries begin to loosen restrictive stay-at-home measures, the [head of the World Health Organization said](#) today "the worst is yet ahead of us" in the COVID-19 pandemic.
