### STATE AND NATIONAL GUIDANCE/EXECUTIVE ORDERS/NEWS

Gov. Gavin Newsom today gave an update on the state's response to the COVID-19 pandemic. (All daily news conferences are streamed *live at noon* on his [Twitter page](#) and the [California Governor Facebook page](#).) You can find more information on [California's COVID-19 website](#).

“This virus doesn’t take the weekends off.” [The governor today chastised Californians](#) who spent the warm weekend at the beach, saying that ignoring restrictions could delay reopening the state. Gov. Newsom [promised to announce](#) modifications to the stay-at-home order soon, saying he will begin holding digital roundtables with workers, small-businesses owners and other employers about the impacts of COVID-19 and plans to emerge from the crisis.

The governor also said Nevada and Colorado are joining California, Oregon and Washington in the [Western States Pact](#) – a working group of Western state governors with a shared vision for modifying stay at home orders and fighting COVID-19.

### SYSTEM GUIDANCE

On March 16, 2020 the Board of Governors granted the chancellor additional authority to help colleges continue to provide educational services to students including the ability to temporarily suspend regulations adopted by the Board of Governors and local rules and regulations. This [executive order](#) and [guidance memo](#) provide the temporary suspension of regulations related to interim appointments to provide maximum flexibility in meeting the immediate need to maintain staffing and continue the educational mission of the community colleges.
