STATE AND NATIONAL GUIDANCE/EXECUTIVE ORDERS/NEWS

Gov. Gavin Newsom today gave an update on the state's response to the COVID-19 pandemic. (All daily news conferences are streamed *live at noon* on his [Twitter page](#) and the [California Governor Facebook page](#).) You can find more information on [California's COVID-19 website](#).

[The governor today said](#) California is “weeks, not months” away from modifying its stay-at-home orders but reiterated the reopening of the state will be gradual, guided by science and done in stages. He and California Department of Public Health Director Dr. Sonia Angell listed the four stages of business to adapt and modify to reopen across the state. We are currently in stage one:

1. Safety and Preparedness – making essential workforce environments as safe as possible;
2. Lower Risk Workplaces – retail/manufacturing/offices/public spaces; modified schools and childcare facilities;
3. Higher Risk Workplaces – gyms/spas/salons, other activities with close contact;
4. Ending Stay-At-Home Order – conventions, entertainment venues, large public gatherings.

Gov. Newsom also said there have also been discussions about [beginning the next school year earlier](#) because of the concern over learning loss from being out of the school environment for so long, but said more information on that is still to come.

The state has launched a new, user-friendly [data portal](#) that tracks COVID-19 cases statewide and by county, gender, age and ethnicity. The portal also outlines statewide hospitalizations and testing efforts. The data presented on the portal will be updated daily and will include additional information as it is available.

SYSTEM GUIDANCE/NEWS

On March 16, 2020 the Board of Governors granted the Chancellor additional authority to help colleges continue to provide educational services to students including the ability to temporarily suspend regulations adopted by the Board of Governors and local rules and regulations. This [executive order](#) and [guidance memo](#) provide the temporary suspension of regulations governing the imposition of penalties for failure to meet the Faculty Obligation Number.
