## STATE AND NATIONAL GUIDANCE/EXECUTIVE ORDERS/NEWS

Gov. Gavin Newsom today gave an update on the state's response to the COVID-19 pandemic. (All news conferences are streamed *live at noon* on his [Twitter page](#) and the [California Governor Facebook page](#).) You can find more information on [California's COVID-19 website](#).

The governor today announced [guidelines for K-12 public schools](#):

- In counties on the state's [COVID-19 watch list](#), schools can only open remotely. Other counties must meet criteria to reopen in person, and counties must be off the watch list for 14 days to resume classes in person.
- All school staff and students in third grade and above must wear masks. Schools must also observe general COVID-19 prevention protocols like temperature checks, handwashing stations and social distancing.
- If a student tests positive, classmates and staff will have to go on a 14-day quarantine. If multiple classrooms/cohorts or more than 5% of the school tests positive, it will need to go on or return to distance learning. A district will return to distance learning if more than 25% of their schools are closed within a 14-day period.
- The state is investing \$5 billion in additional funding to enhance learning during the pandemic to promote a more rigorous distance learning program and to address the digital divide across the state.

Among the other headlines from today's update:

- California now has [366,164 confirmed cases](#) of COVID-19 and 7,475 deaths, an increase of 1.8% from the day before.
- The state has performed nearly 6.1 million tests and the test positivity rate over the past 14 days is 7.4%.
- San Francisco is now the 32<sup>nd</sup> county on the state's watch list, and the city is now pausing reopening plans indefinitely to slow the spread of coronavirus.

Gov. Newsom on Thursday [announced the availability of \\$600 million in funding](#) for Homekey, the next phase in the state's response protecting Californians experiencing homelessness who are at high risk for serious illness from COVID-19.

Cal/OSHA on Thursday urged all employers in California to follow the state's COVID-19 [workplace safety and health guidance](#) to ensure their workers are protected from the virus. The guidance is designed to help employers comply with obligations to implement effective measures to train and protect employees.

The state [added a record 558,000 jobs in June](#) as more businesses reopened. However, the gains announced today are expected to be short-lived because of new closures put into effect in July as the coronavirus surged.

Nationally, more than [77,000 new cases](#) were reported Thursday, beating the old single-day record by nearly 10,000.

A new [Washington Post/ABC News poll](#) finds President Trump faces rising disapproval and widespread distrust on his response to the coronavirus pandemic.

The Centers for Disease Control today said its [delaying the release of updated guidance](#) on how to safely reopen schools. The guidance was due this week; the CDC now says it will be released by the end of the month.

[Millions of Americans' unemployment payments will abruptly shrink soon](#). The \$600 weekly unemployment stimulus, granted through the Cares Act, is scheduled to end July 31 if Congress doesn't find a solution in the next week to extend emergency benefits.

Black Minds Matter is a national movement that draws parallels between the policing of Black lives and schooling of Black minds. The webinar series will balance a discussion of issues facing Black students as well as offer research-based strategies for improving their success.
