STATE AND NATIONAL GUIDANCE/EXECUTIVE ORDERS/NEWS

Gov. Gavin Newsom today gave an update on the state's response to the COVID-19 pandemic. (All news conferences are streamed *live at noon on his [Twitter page](#) and the [California Governor Facebook page](#).*) You can find more information on [California's COVID-19 website](#).

The governor today was joined by faith leaders to address this weekend's protests across the state and nation, as well as the ongoing COVID-19 pandemic. Gov. Newsom called what's going on around this country, "a pandemic on top of a pandemic," and said, "The Black community is not responsible for what's happening in this country right now. We are. Our institutions are responsible and we are accountable to this moment... people have lost patience because they haven't seen progress." The governor did call for the end of violent protests and said the state remains committed to bringing peace back to the streets.

The governor on Friday [issued an executive order](#) extending authorization for local governments to halt evictions for renters impacted by the COVID-19 pandemic, through July 28. The executive order also extends the waiver permitting the Department of Motor Vehicles to allow for mail-in renewals of driver's licenses and identification cards, and waives certain programmatic and administrative requirements that restrict child care and afterschool programs from serving children of essential infrastructure workers.

The [U.S. Senate is expected to soon take up](#) and pass legislation to further strengthen the Paycheck Protection Program. The House has already approved the bill.

[Public health officials are warning](#) the protests taking place around the country could lead to another outbreak of the coronavirus. While protests are generally held outside, where the virus doesn't spread as readily, they have led to the closures of testing centers and health clinics, which experts say could "[be giving the virus another head start.](#)"

Despite widespread economic toll, most [Americans still favor controlling outbreak](#) over restarting economy, a new poll finds.
