COVID-19 Update

June 29, 2020 – COVID-19 Update No. 67



Los Angeles Southwest College served as the first stop in a national COVID-19 testing program sponsored by grocery retailer Kroger and its supermarket chain, Ralphs. The pharmacy team last week administered COVID-19 tests to hundreds of community members on the LASC campus.

STATE AND NATIONAL GUIDANCE/EXECUTIVE ORDERS/NEWS

Gov. Gavin Newsom today gave an update on the state's response to the COVID-19 pandemic. (All news conferences are streamed [live at noon on his Twitter page](#) and the [California Governor Facebook page](#).) You can find more information on [California's COVID-19 website](#).

Among the headlines from today's update:

- California now has 216,550 confirmed cases of COVID-19, resulting in 5,936 deaths. The state has seen a 45% increase in new COVID-19 cases over the past seven days, with a positivity test rate of 5.9%.
- Statewide hospitalizations are up 43% and ICU admission rates are up 37% over last few weeks.
- Nineteen counties are now getting "[targeted engagement](#)" from the state because of the increase in COVID-19 rates, up from 15 counties on Friday. Solano, Merced, Orange and Glenn counties were added to the list today.
- More than a thousand inmates at San Quentin State Prison have tested positive, along with 89 staff members. Newsom said his administration is considering 3,500 non-violent, non-sex offender inmates for early release but also said it's "imperative" not to release inmates without a place to go and potentially compound the problem.
- The state will be stepping up enforcement of COVID-19 rules and regulations to help stop the alarming recent spread of cases.

[The governor now has the state budget](#) and is expected to sign it yet today. The California Assembly on Friday voted to approve the spending plan, which addresses the state's \$54 billion budget shortfall. The Senate approved the budget last Thursday.

Gov. Newsom and the California Department of Public Health on Sunday [released updated guidance](#) requiring bars to temporarily close in seven California counties (Fresno, Imperial, Kern, Kings, Los Angeles, San Joaquin and Tulare), and recommending bars to temporarily close in another eight counties (Contra Costa, Riverside, Sacramento, San Bernardino, Santa Barbara, Santa Clara, Stanislaus and Ventura).

"Los Angeles County is now projecting the possibility of running out of hospital beds in two to three weeks." As the number of cases in L.A. County today surpassed the [100,000 mark](#), county health officials issued a [dire warning](#) that conditions amid the coronavirus pandemic are deteriorating rapidly and the virus is again spreading swiftly in the community.

Sacramento County today [ordered bars to close tonight](#), saying patrons are not practicing social distancing and are contributing to the rise in cases across the county. County officials also reminded residents that indoor gatherings of any size with people outside of your household are prohibited by both local and state health orders.

Contra Costa County today [delayed the opening of businesses and activities](#) previously planned for July 1 until the COVID-19 outbreak in Contra Costa is better contained.

Alameda County today is also [temporarily pausing reopening plans](#) and will be extending its timeline for the next phase of reopening.

House Speaker Nancy Pelosi and Senate Minority Leader Chuck Schumer today called on Sen. Mitch McConnell to start negotiations on [new coronavirus relief bill](#) as economic worries continue with increase in cases.

[Tracking coronavirus cases](#) is proving difficult amid the new surge across the country, and Dr. Anthony Fauci, the nation's top infectious disease expert, says [herd immunity against COVID-19 is unlikely](#) if not enough Americans get the vaccine.

"The reality is this is not even close to being over." The World Health Organization is [planning to send a team](#) to China next week to try to understand the origins of the novel coronavirus and how it can be contained.
