## STATE AND NATIONAL GUIDANCE/EXECUTIVE ORDERS/NEWS

Gov. Gavin Newsom today gave an update on the state's response to the COVID-19 pandemic. (All daily news conferences are streamed *live at noon* on his [Twitter page](#) and the [California Governor Facebook page](#).) You can find more information on [California's COVID-19 website](#).

The governor today announced:

- [More than 1 million diagnostic tests for](#) the coronavirus have been conducted statewide. Increased testing is one of the [six critical indicators](#) for modifying stay-at-home orders.
- The [California Department of Consumer Affairs and State Board of Pharmacy](#) will allow pharmacists to collect specimens for COVID-19 tests and order tests for consumers.
- The state has created a new “Medi-Nurse” line available for Medi-Cal patients without a health plan (fee for service) and uninsured Californians. The line is [1-877-409-9052](#) and is available 24/7 for COVID-19 concerns or for general medical issues.
- California office and mall workers who can't telework [can now return to work](#). Employers must adhere to a strict set of modifications before employees can come back.

[Butte](#) and [El Dorado](#) counties in Northern California are the first two counties [to get the okay](#) from the state to reopen some businesses.

The [Los Angeles County public health director today said](#) the county “with all certainty” will keep stay-at-home orders in place until July. She did not issue an official order but said the timeline would only change if there were swift changes in the virus and/or testing.

Dr. Anthony Fauci, the nation's top infectious disease expert, today [told a Senate committee](#) that the country will face "really serious" consequences of suffering, death and deeper economic damage if stay-at-home orders are lifted too quickly.

House Speaker Nancy Pelosi today unveiled a [\\$3 trillion coronavirus aid package](#) that would provide nearly \$1 trillion for states and cities. The House could vote as early as Friday; the Senate will not take up the bill until after Memorial Day.



#### SYSTEM GUIDANCE/NEWS

The California Community Colleges, seeking to protect hundreds of thousands of students denied eligibility to federal emergency student assistance, filed a [lawsuit](#) Monday to stop the U.S. Department of Education from placing arbitrary eligibility restrictions on relief funds Congress approved to mitigate the effects of the COVID-19 pandemic. The lawsuit was filed against Education Secretary Betsy DeVos. Joining the lawsuit against DeVos is the Los Angeles Community College District, the Los Rios Community College District, the State Center Community College District, the Foothill-De Anza Community College District and the San Diego Community College District. California Attorney General Xavier Becerra is representing the Board of Governors and the Chancellor. [Read the full news release here.](#)
