## STATE AND NATIONAL GUIDANCE/EXECUTIVE ORDERS/NEWS

Gov. Gavin Newsom today gave an update on the state's response to the COVID-19 pandemic. (All daily news conferences are streamed *live at noon on his [Twitter page](#) and the [California Governor Facebook page](#)*.) You can find more information on [California's COVID-19 website](#).

The governor today announced [10 more California counties](#) have been given the okay to reopen, with modifications. Discussions are underway with 31 of the state's 58 other counties to begin the reopening process, but Newsom said [conditions are still too serious in Los Angeles and San Francisco counties](#) to modify guidelines for resuming business in those areas.

Gov. Newsom, speaking today from an El Dorado County fire station, also provided an update on the state's wildfire preparedness efforts, saying California continues to act at an emergency pace to protect communities most at risk from wildfires during the COVID-19 pandemic.

Tomorrow, the governor is set to release his May Revision budget proposal for the 2020-21 fiscal year. Due to the current public health emergency, he's expected to release a drastically different budget from the initial proposal in January. Last week, his administration projected a \$54.3 billion deficit for the coming budget year.

## SYSTEM GUIDANCE/NEWS

On March 16, 2020 the Board of Governors granted the Chancellor additional authority to help colleges continue to provide educational services to students including the ability to temporarily suspend regulations adopted by the Board of Governors and local rules and regulations. Chancellor Eloy Ortiz Oakley today issued an [executive order](#) and [guidance memo](#) to provide the temporary extension of fiscal reporting due dates. This information is posted on the [Chancellor's Office Communications to Colleges](#) section of the [Chancellor's Office COVID-19 resource page](#).

COVID-19 Emergency Conditions Allowance Forms are due on Friday, May 15th. If your district submits the [emergency conditions allowance form](#), the Chancellor's Office will use your P1 FTES information in 2019-20 and any future years where 2019-20 FTES is used, such as the 3-year average used to calculate the traditional credit FTES.

The Cabrillo College governing board on Tuesday [voted unanimously](#) in support of a resolution urging the U.S. Department of Education and Secretary Betsy DeVos to allow colleges and universities to distribute CARES Act emergency funding to all students.
