STATE AND NATIONAL GUIDANCE/EXECUTIVE ORDERS/NEWS

Gov. Gavin Newsom today gave an update on the state's response to the COVID-19 pandemic. (All daily news conferences are streamed *live at noon* on his [Twitter page](#) and the [California Governor Facebook page](#).) You can find more information on [California's COVID-19 website](#).

[The governor today said](#) California has been able to flatten the curve. The state had its [first-ever week-over-week decline](#) in reported coronavirus deaths and today reported 1,275 new positive cases since its last reporting. The number of cases has remained fairly consistent over the past few days despite an increase in testing. While again acknowledging the growing push to reopen the state, Newsom maintained we can't move too quickly and need to continue stay-at-home orders and appropriate social distancing. Newsom also announced he has reached a deal with Huntington Beach, Dana Point and Seal Beach to reopen their beaches.

The California DMV says offices [could reopen as soon as this month](#), albeit with limited services and new requirements.

Vice President Mike Pence today said the [White House's coronavirus task force](#) could wind down within a month because "of the tremendous progress we've made as a country." This comes as the overall [U.S. infection rate is rising](#) as states reopen.
