## STATE AND NATIONAL GUIDANCE/EXECUTIVE ORDERS/NEWS

Gov. Gavin Newsom today hosted a digital roundtable with Californians who work in the film and television industry. Participants discussed how they are dealing with the COVID-19 crisis, how they are adapting their workplaces in the weeks and months ahead, and what opportunities they see to reinvent their businesses, industries, consumer habits and our state's economy. The governor on Tuesday [signed an executive order](#) addressing a number of issues related to the coronavirus pandemic. The executive order:

- Eases the strain on domestic violence service providers by waiving the 10% cash or in-kind matching requirements for state grants awarded to these organizations.
- Waives the deadline to verify grade point average and waives certain certification requirements and selective service registration verification for Cal Grant applicants.
- Suspends programmatic deadlines for entities that receive funding from the Energy Commission for the development and deployment of new technologies that support the state's clean energy and decarbonization goals.
- Extends the timeframe for local governments to submit claims for reimbursement to the State Controller's Office.

The California Department of Public Health has issued a communication that indicates the reopening of higher education for large scale in-person operations is not permitted in Stage 2, which includes K-12, of the state's reopening. Stage 2 reopening is under way and varies by county. In the [communication](#) dated May 18, the department said: "The goal continues to be to open the state in a way that minimizes the risk for COVID-19 to the extent possible, which includes: 1) limiting non-essential movement and mixing of populations, especially within jurisdictions with higher confirmed cases, and 2) delaying the opening of environments in which there is prolonged and close contact as part of the way business must operate."

State Superintendent Tony Thurmond today said [during a media check-in](#) that the Department of Education is considering new rules for how schools will open, including requirements of face masks for students and teachers, and sanitizing classrooms possibly multiple times a day. State Superintendent Thurmond tomorrow will hold a digital event with all California school districts to discuss the safe reopening of our schools. It will focus on three subject areas: health & safety, educational programs and fiscal implications. The webinar is Thursday, May 21 at 10:00 a.m. and the public is invited to listen in. The CDC has released [new guidance](#) on how public aquatic centers, including those managed by schools, should operate during the pandemic.

While the U.S. and other countries move towards reopening, a grim reminder today the pandemic is far from over: [More than 100,000 coronavirus cases have been reported](#) to the World Health Organization in the last 24 hours, "the most in a single day since the outbreak began."

This webinar will include one or more math instructors from California and Colorado who have worked with CUE on developing pedagogical practices that are critically race conscious. This session will address: (1) traditional vs equity-minded conceptions of the ways in which math is done and thought about, (2) how to draw upon student's knowledge, (3) noticing racialized patterns in data close to practice (gradebook and attendance mapping, designing homework problems), (4) engaging students conversations that focus on how they are experiencing the online environment.
