SUBJECT: Notification of Fiscal Year 2017-18 Cooperating Agencies Foster Youth Educational Support Allocations

Synopsis: The Chancellor's Office is pleased to release the Cooperating Agencies Foster Youth Educational Support (CAFYES) allocations for fiscal year 2017-18. The 2017-18 First Principal Apportionment (P1) report will reflect **\$10,686,041** to 10 districts to operate CAFYES programs at 26 colleges within those districts.

In accordance with Chapter 771, Statutes of 2014, the Board of Governors entered into agreements with 10 districts to provide additional funds, separate and apart from current funding, for services in support of postsecondary education for foster youth through a supplemental component of the existing Extended Opportunity Programs and Services (EOPS) program. CAFYES shall expand and not displace the number of students served through EOPS. It offers students enrolled in CAFYES a breadth of support and services that is "over, above and in addition to" what they are entitled to receive from other college programs. District and college funds cannot be supplanted by CAFYES monies.

The purpose of CAFYES is to encourage the enrollment, retention and transfer of current and former foster youth who meet CAFYES eligibility in the California Community Colleges by establishing an educational program that provides services promoting their academic success.

Colleges' 2017-18 budget requests are accepted. However, technical assistance may be provided to colleges on specific 2017-18 line item expenditures.
