### **For MIS Data Submission, Perkins Reporting, Certification, and Allocation Determination**

The following timeline provides important dates and deadlines for the Perkins V allocation process. *Dates provided are subject to change by the Chancellor's Office (CO).* Deadlines for districts that impact Perkins Title I, Part C (I-C) allocations are indicated as bold text. Fiscal report dates are indicated in pink, however, the Legal Terms and Conditions, Article I, Section 3 notes that: *all reports that fall on a weekend or a holiday are due by close of business on the last working day **prior to the reporting deadline**.* Extensions of reporting deadlines may be made with the approval of the Project Monitor.

October 1, 2022	District 2021 -22 Financial Aid data due to the Chancellor's Office. *Note: Failure to submit complete and accurate 2021-22 Term or Financial Aid data by the February 18, 2023 deadline may have a negative effect on your Perkins allocation. Districts have the opportunity to correct data submitted for Perkins Title I-C funding purposes until the deadline. MIS data resubmissions after February 18, 2023 are not used for Perkins Title I-C allocations.	
October 15, 2022	1st Qtr. Report fiscal year 2022-23 is due.	Q
December 1, 2022	This is the deadline for resubmission of 2021-22 Financial Aid data for use in the SFA reconciliation for BFAP-SFAA administrative funding.	
December 30, 2022	Final Report for Regional Consortia (RC) is due	Q
January 5, 2023*	Section 132 Preliminary Reports #1 & #2 are run by CO MIS. * The 2023-24 Perkins Title I-C allocation will be based on the student counts in these reports.	Cert
January 11, 2023	Allocation student counts in Section 132 Preliminary Reports #1 & #2 with certification forms are posted online ( <a href="#">NOVA</a> ). For Student Counts : <a href="#">Click Here</a>	Cert
January 15, 2023	2nd Qtr. Report for fiscal year 2022-23 is due.	Q
February 2023	First Principal Apportionment (P1) includes <b>Recalculation</b> Apportionment based on districts' 2021 -22 Final Reports of Expenditures.	
February 18, 2023	District certification form is due in the CO indicating data certification or resubmission (requests new certification form).	Cert
February 17, 2023	This is the deadline for resubmission of MIS data for use in 2023 - 24 Perkins funding allocation.  To meet district planning and state funds distribution requirements, the first certification of the counts of economically disadvantaged CTE students must occur in February. <b>It is critical that resubmissions and certifications occur within the scheduled timeline to provide sufficient planning time for districts.</b>	Cert
February 24, 2023	This is the date of the final run of Perkins Title I-C Section 132 Reports #1 & #2 by CO MIS.

July 1, 2023	Perkins V 2023-24 Title I-C grants become effective. District Applications must be substantially approved by the CO prior to July 1, 2023, for expenditures to begin.	LA
July 15, 2023	4th Qtr. Report for fiscal year 2022-23 is due	Q
August 31, 2023	Perkins Title I-C/Reserve & Title I-B Final Reports for fiscal year 2022-23 are due.	FR
