### Timeline for Perkins IV Program Years 2016-17, 2017-18, and 2018-19

#### For MIS Data Submission, Perkins Reporting, Certification, and Allocation Determination

The following timelines provides important dates and deadlines for the Perkins allocation process. *Dates provided are subject to change by the Chancellor's Office (CO).* Deadlines for districts that impact Perkins Title I, Part C (I-C) allocations are indicated as bold text. Fiscal report dates are indicated in pink, however, the Legal Terms and Conditions, Article I, Section 3 notes that: *all reports that fall on a weekend or a holiday are due by close of business on the last working day prior to the reporting deadline.* Extensions of reporting deadlines may be made with the approval of the Project Monitor.

#### The cycle for the 2017-18 Program Year

July 1, 2017	Perkins 2017-18 Title I-C grants become effective. District Applications must be substantially approved by the Chancellor's Office prior to July 1, 2017 for expenditures to begin.
July 11, 2017	2016-17 Online Title I-C Final Report System Activated
July 15, 2017	4th Qtr. Report for program year 2016-17 is due.
August 31, 2017	Perkins Title I-C/CTE Transition & Title I-B Final Reports for program year 2016-17 are due
October 1, 2017	District 2016-17 Financial Aid data due to the Chancellor's Office. Failure to submit complete and accurate 2016-17 Term or Financial Aid data by the <b>February 19, 2018</b> deadline may have a negative effect on your Perkins allocation. Districts have the opportunity to correct data submitted for Perkins Title I-C funding purposes until the deadline. MIS data resubmissions after <b>February 19, 2018</b> are not used for Perkins Title I-C allocations.
October 15, 2017	1st Qtr. Report for program year 2017-18 is due.
December 1, 2017	This is the deadline for resubmission of 2016-17 Financial Aid data for use in the SFA reconciliation for 2016-17 BFAP-SFAA administrative funding.
January 5, 2018*	Section 132 Preliminary Reports #1 & #2 are run by CO MIS. * The 2018-19 Perkins Title I-C allocation is based on the student counts in these reports.
January 11, 2018	Allocation student counts in Section 132 Preliminary Reports #1 & #2 with certification forms are posted (beginning of January 2017) to web to Student Counts : <a href="#">Click Here</a>

January 15, 2018	2nd Qtr. Report for program year 2017-18 is due.
February 2018	First Principal Apportionment (P1) includes <b>Recalculation</b> Apportionment based on districts' 2016-17 Final Reports of Expenditures.
February 19, 2018	District certification form is due in the CO indicating data certification or resubmission (requests new certification form).
February 20, 2018	This is the deadline for resubmission of MIS data for use in 2018-19 Perkins funding allocation.  To meet district planning and state funds distribution requirements, the first certification of the counts of economically disadvantaged CTE students must occur in February. <b>It is critical that resubmissions and certifications occur within the scheduled timeline to provide sufficient planning time for districts.</b>
February 24, 2018	This is the date of the final run of Perkins Title I-C Section 132 Reports #1 & #2 by CO MIS.
February 29, 2018	Perkins Title I-C Section 132 Reports #1 & #2 are posted to web (new certification forms for districts with resubmissions will also be posted).
March 7, 2018*	Tentative 2018-19 Allocations for Perkins Title I-C/CTE Transitions are posted to web.
March 14, 2018*	2018-19 Perkins Title I-C/CTE Transitions District Local Application (online) opens for data entry.
March 19-20, 2018	BOG to approve 2018-19 Workforce & Economic Expenditure Plan
March 28, 2018	Resubmission certification form is due for districts submitting data to correct counts before February 19, 2018.
April 15, 2018	3rd Qtr. Report for program year 2017-18 is due.
May 15, 2018	The 2018-19 Perkins Title I-C/CTE Transitions District Local Application (online) is due.
July 1, 2018	Perkins 2018-19 Title I-C grants become effective. District Applications must be substantially approved by the CO prior to July 1, 2018 for expenditures to begin.
July 15, 2018	4th Qtr. Report for program year 2017-18 is due
August 31, 2018	Perkins Title I-C/CTE Transition & Title I-B Final Reports for program year 2017-18 are due.

\*These dates are tentative, contingent on the actual announcement of district allocation determinations.
