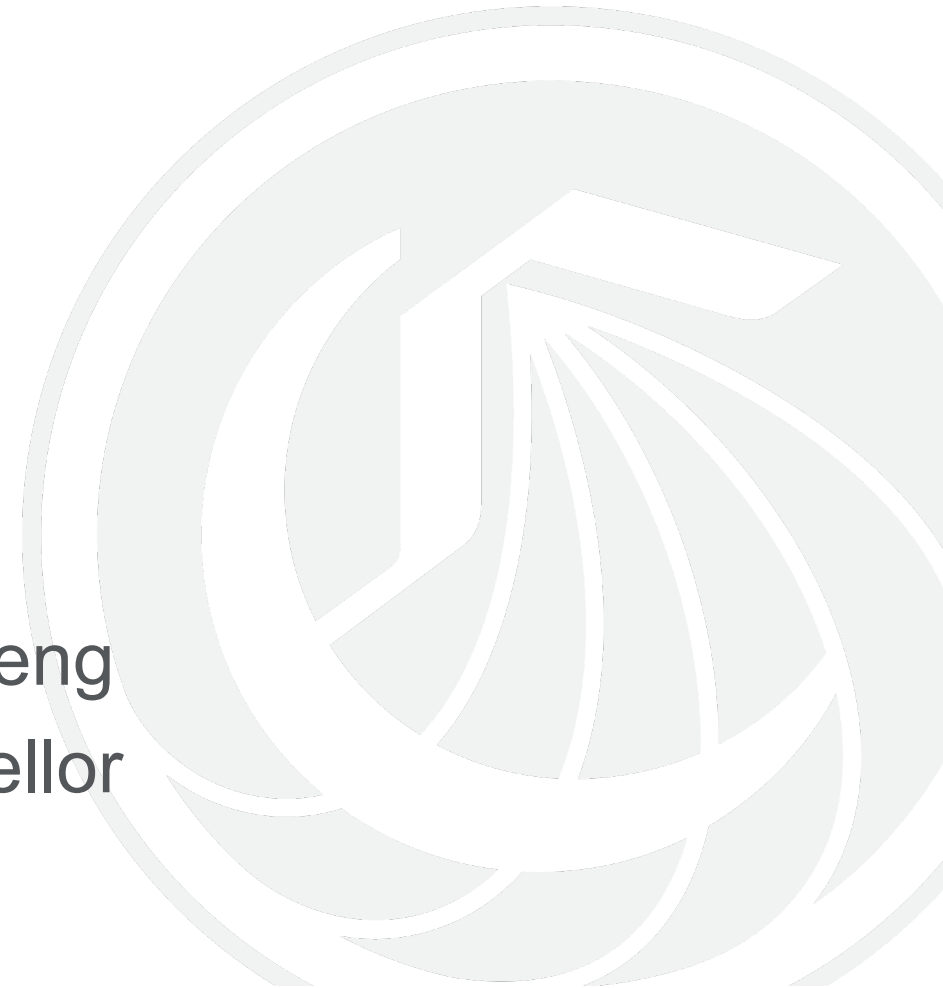

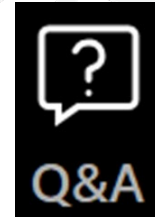

CCN: Context & History

- Articulation of courses needs to be more clear and more consistent for students
- Education Code 66275, amended by AB 1111 (2021, Berman) and AB 3290 (2024, Committee on Higher Education)
- [Report and Recommendations](#) (2023) developed by [AB 1111 Task Force](#), with intersegmental & cross-function membership
- [Common Course Numbering Project](#) to implement recommendations via intersegmental collaboration of Council and workgroups and using a phased approach
- Vision of system-level articulation from community colleges to universities using CCN course templates for common transferability, common GE applicability, consistent course-to-course articulation from all CCCs, and potential for more consistent major prep articulation

Instruction:

Phase II Templates and Local Implementation

- Part A Templates released in March for eight Phase II courses
 - Includes honors templates for all 8 courses
 - **Target: Implementation by Fall 2026**
- Part B Templates to be released for 15 more Phase II courses
 - Includes lecture only, lab only, and lecture/lab templates as needed to fit local college course structures and scheduling patterns for STEM courses
 - Post-development surveys open April 16 for three weeks (additional vetting)
 - **Target: Implementation by Fall 2027**
- ***Include the C in the course number***
- ***Include PART 1 Template language in local course outline***

“C” equals a CCN course

CCN course taxonomy: **ENGL C1000 Academic Reading and Writing**

Phase III Template Development and Local Implementation Timelines

- **Phase III = 47 courses to be implemented by Fall 2027**
- Templates to be developed by 18 Common Course Numbering Faculty Workgroups (CCNFWs) facilitated by ASCCC in June 2025
- Surveys are opportunity for statewide intersegmental faculty input
 - Pre-development surveys currently open through April 15
 - Find surveys at [ASCCC Common Course Numbering Development and Faculty Engagement webpage](#) (see Open Surveys tab)
- Nomination period for CCNFWs through April 15 via academic senate presidents
- Expected finalization by ASCCC and release of templates by Chancellor's Office by December 2025/January 2026

Chancellor's Office Curriculum Inventory

- Closing out Phase 1 CCN implementation:
 - Part 2 fields will be released in late spring
 - Content uploaded in the optional supplemental workbooks will be migrated in waves for 6 weeks post release
- Traditional and Common Course Alignment
 - COR data elements added to course form for all Credit Courses
 - Template content will populate most of the fields for CCN Courses
 - College Submitters will populate the COR fields for Traditional
- Office Hours are Mondays and Wednesdays from 9:30 - 10:00 with dates posted through July

ARTICULATION

- Segment updates to support CCN vision for articulation:
 - UC
 - UC TCA submission for Phase I CCN-aligned CORs postponed – due summer 2025
 - UC TCA submission for Phase II CCN-aligned CORs postponed – due summer 2026
 - CSU
 - Campuses have been asked, and have agreed, to review the templates for course-to-course articulation for Phase I
 - Independents
