Final Regulation Text of Annual Audit Reports Due Date.

SECTION 59106 OF SUBCHAPTER 3 OF CHAPTER 10 OF DIVISION 6 OF TITLE 5 OF THE CALIFORNIA CODE OF REGULATIONS IS AMENDED TO READ:

§ 59106. Annual Audit Reports Due Date.

~~Not later than December 31st, an audit report for e~~Each district shall file an audit report with the Chancellor's Office, and with other agencies specified in the Chancellor's Contracted District Audit Manual, for the preceding fiscal year required by Section 84040 of the Education Code shall be filed with the no later than December 31, unless this date is extended by the Chancellor's Office, Board of Governors, the Department of Finance and other regulatory agencies in accordance with Section 84040.5 of the Education Code. The Chancellor may issue guidelines for use by districts in complying with this section.
