 - a. Generative Al
 - RSI ensuring course design strengthens and clarifies standards for instructor-student interaction aligned with federal regulations

 - 1. Rules are rules until they are removed from being rules
 - 2. RSI standards are maintained
 - 3. Accessibility requirements for April 2026/2027
 - 4. State Authorization remains in-place
 - c. Distance Education Regulation Proposals' status
 - 1. Attendance taking for all distance education courses
 - 2. No Title 4 aid for asynchronous clock hour programs
 - 3. Creating virtual location for distance education programs
 - 4. Online program management
 - a. Most of these newly proposed regulations are not expected to be completed and effective



- d. Issues to watch with Washington DC administration change
 - 1. DEI is sought to be eliminated or removed
 - 2. "Protect free speech"
 - 3. A new focus on academic content
 - 4. Access and affordability
 - 5. Alternatives to 4-year degrees
 - 6. Return on investment (ROI) which could be a removal of Title IV eligibility for certain disciplines in the name of economic value
 - 7. Belief that all higher education is workforce related
 - a. Move skills requirements for public jobs
 - b. Degrees should tie to jobs
 - c. Support short-term Pell Grants shorter credentials and Pell for alternative institutions
 - 8. Some talk to eliminate Dept of Education likely will not happen; however, decreases to staffing levels is likely with attrition of career staff
 - a. Could seek reclassification of federal employees as
 - b. Could farm-out particular functions of the Dept of Education such as FAFSA processing and federal loan servicing
 - 9. Low level discussions about a free national online university that is not likely to manifest
 - 10. CVC covers membership for all CCCs WCET wants to identify a lead person at each institution (share lead with Cheryl Dowd & Marina Aminy)
 - 11. Inter-state compliance issues (state authorization for institutions with students and faculty who are out-of-state) must be aware of where all students are located, document it, and provide this information to the Sect of Education upon request; formal receipt of information if the student moves to a different state
 - a. The college has the responsibility to adhere to the standards for the state where the student is now residing
 - 12. All modalities must have public disclosures for where the program meets and does not meet (states and territories where the institution serves students)
 - a. Students in different states must be notified if program requirements change
 - 13. Certifies that programs leading to a certification ensure that licensing requirements will be met for the state where the student resides
 - a, at the point of initial enrollment
 - b. when the student attests a state where the student intends to seek employment
