4. Competency Based Education (Erin)
 - In depth discussion regarding CBE
 - Currently on a pilot stage
 - 8 colleges working as part of a Collaborative to offer Direct Assessment CBE programs
 - 4 of the colleges:

- already received approval from ACCJC
 - preparing applications to the US Dept of Ed
- Programs planning to launch fall 2024
- Working groups focusing on specific topics, e.g., technology, financial aid, student services
- \$500,000 grants to colleges for designing, developing and implementing programs, tied to milestones
- *CBE at Scale:*
 - Currently gathering feedback on a draft funding method
 - Pay based on competencies mastered rather than on attendance represents a major cultural shift, with many logistical implications
 - Potential to transform the system
- *Colleges concerns noted*
 - Not accepted to a university
 - Funding and vetting
 - Federal rules have changed and title 5 must be updated to align with changes.
- *CBE to be seen as a melding of:*
 - cohort-based programs + open-entry-exit
 - for credit AA degrees that are workforce/industry aligned.
