Overview -- Ways to Participate

Campuses and faculty can engage in the project in the following ways:

1. Through determining the most effective practices for corequisite design and execution. This will involve engagement with your Math department leadership, faculty, and related campus staff (tutoring center, counseling/advising, etc.). This will include an opportunity to pilot the beta version of the new *Just In Time Math* tools and iterate with the project team to continuously improve the platform and provide feedback on necessary elements to implement the tools for maximum impact with emphasis on equity and access (i.e., user feedback, internal processes, policy alignment, professional development). Stipends will be available for faculty who are willing to pilot courses and provide feedback.
2. Through faculty members joining a systemwide workgroup to assist in the tuning and improvement of the *Just In Time Math* platform to select and organize the content, learning materials and formative assessment, particularly to customize it for a California Community College context of equity and access. Stipends will be provided at several levels of engagement.
3. Through CTE faculty and subject matter experts joining smaller workgroups to explore the application of *Just In Time Math* to three occupational pathways to design a *WorkReady Math* system that contextualizes and streamlines the math learning necessary for those occupations and skills. Stipends will also be provided.

We hope that committed campuses will engage in all the activities listed above. However, there will be opportunities to engage in individual components per the interest of the campus and faculty.
