## State and Federal Policy Update

This document is prepared by the California Community Colleges Chancellor's Office as part of its regular monthly and bimonthly updates for the Consultation Council and the Board of Governors, respectively. The information presented herein is current as of April 25, 2025, at the time of items were due. The latest information will be provided at the time of the presentation.

#### STATE LEGISLATION OVERVIEW

As of this writing, the Chancellor's Office is tracking 83 Tier 1 Assembly Bills (AB) and Senate Bills (SB). These bills are most likely to have a direct impact on the California Community Colleges, students, faculty, staff, operations, programs, and services.

#### **CONGRESSIONAL UPDATE**

# **Budget Update**

On May 2, 2025, President Donald Trump sent an outline of his proposed budget, commonly known as the "skinny budget," for Fiscal Year (FY) 2026 to Congress for their consideration. As is expected during the first year of a new administration, the simplified budget submission provides a summary of what the President would like to see in terms of government spending for the next fiscal year, which begins on October 1, 2025.

The cuts proposed in President Trump's budget submission represent an overall 22.6% reduction in projected spending from FY 2025 enacted levels. (Note that the skinny budget

proposal does not address "entitlement" spending, most notably for Medicare, Medicaid and Social Security.)

# Brief skinny budget highlights: cuts proposed for domestic, non-defense spending

The President is proposing a total of \$163 billion in cuts to non-defense spending, most notably:

- Education funding would be cut by 15%.
- The National Science Foundation's budget would be cut by more than 50%.
- The Environmental Protection Agency's budget would be cut by more than 50%.

The following programs are proposed for termination:

- The National Endowment for the Arts
- The National Endowment for the Humanities
- The Corporation for Public Broadcasting
- AmeriCorps

Defense and border security are proposed for significant increases, including:

- A 13% increase for defense spending.
- A 65% increase for the Department of Homeland Security for border security efforts.

## **Next Steps**

The House and Senate Appropriations Committees will be holding hearings on the administration's budget proposals in the weeks ahead. The administration's full budget, including all spending and revenue projections, will follow in the coming months.

Congress has completed its work on FY 2025. A final continuing resolution was passed in March to fund the government through the end of the fiscal year. However, as of early May 2025, Congress is currently working on the annual appropriations for FY 2026, which determines discretionary spending from October 1, 2025, to September 30, 2026.

On April 29, 2025, the House Education and Workforce Committee held a markup session for budget reconciliation legislation, as directed by the recently passed budget resolution House Concurrent Resolution 14 (H.Con.Res. 14). This resolution outlines the federal budget for fiscal year 2025 and sets budgetary levels through 2034. The Committee was tasked with developing legislation that achieves **at least \$330 billion** in savings (cuts) over the next decade.

The proposed bill covers a range of higher education issues, including student eligibility, loan limits, repayment terms, Pell Grants, accountability measures, regulatory relief, and restrictions on federal authority. Among other things, this proposal would limit Pell Grant eligibility for hundreds of thousands of community college students, by increasing the number of units students must take to receive federal financial aid. This legislation was approved by the Committee with a 21-14 vote and will be combined with proposals from other committees into a broader reconciliation package for consideration on the House floor.

#### **ADMINISTRATION**

## **Department of Education**

On April 29, the U.S. Department of Education's Office of Postsecondary Education held its first public hearing for the 2025 negotiated rulemaking on various programs authorized under Title IV of the Higher Education Act of 1965 - SAVE, Income-Contingent Repayment, and PSLF, or other topics that would streamline current federal student financial assistance programs. The U.S. Department of Education published the press release (www.ed.gov/about/news/press-release/us-department-of-educations-office-of-postsecondary-education-announces-negotiated-rulemaking). The Notice of Proposed Rulemaking (NPRM) was officially published and the Department has announced an extension of the comment deadline from May 5 to May 8. Another notice will be published providing more detail on negotiated rulemaking dates and nominations. ## **Executive Orders and Memorandums**

April 28, President Trump issued an executive order titled *Protecting American Communities from Criminal Aliens*, directing the Department of Homeland Security to publish a list of "sanctuary" jurisdictions that do not cooperate with federal immigration authorities. The order requires those jurisdictions to comply with immigration orders, or risk losing federal funding. We are monitoring the order and any pertinent discussions and actions.

April 9, President Trump issued a Presidential Memorandum, *Directing the Repeal of Unlawful Regulations*, ordering the evaluation of existing regulations under *Loper Bright Enterprises v. Raimondo*, *Students for Fair Admissions v. Harvard*, and *Carson v. Makin*, among a list of ten recent Supreme Court decisions. It states, "in effectuating repeals of facially unlawful regulations, agency heads shall finalize rules without notice and comment, where doing so is consistent with the 'good cause' exception in the Administrative Procedure Act." Also, agency heads must "submit to the Office of Information and Regulatory Affairs a one-page summary of each regulation that ... has not

been targeted for repeal, explaining the basis for the decision not to repeal that regulation." The Memorandum can be found on the <a href="Whitehouse webpage">Whitehouse webpage</a> (https://www.whitehouse.gov/presidential-actions/2025/04/directing-the-repeal-of-unlawful-regulations/).

# Antisemitism Awareness Act (S. 558) and Protecting Students on Campus Act (S. 163)

On April 30, the Senate HELP Committee considered S. 558, *Antisemitism Awareness Act*, providing for the consideration of a definition of antisemitism set forth by the International Holocaust Remembrance Alliance for the enforcement of Federal antidiscrimination laws concerning education programs or activities, and for other purposes, and S. 163, *Protecting Students on Campus Act*, requiring institutions of higher education participating in Federal student aid programs to share information about title VI of the Civil Rights Act of 1964, including a link to the webpage of the Office for Civil Rights where an individual can submit a complaint regarding discrimination in violation of such title, and for other purposes. Votes on both bills were postponed.
