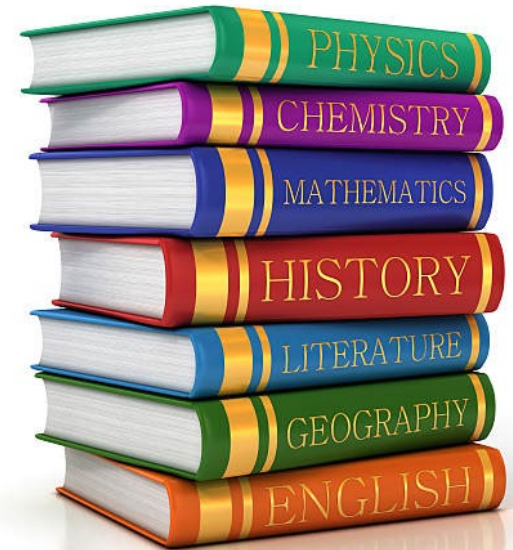

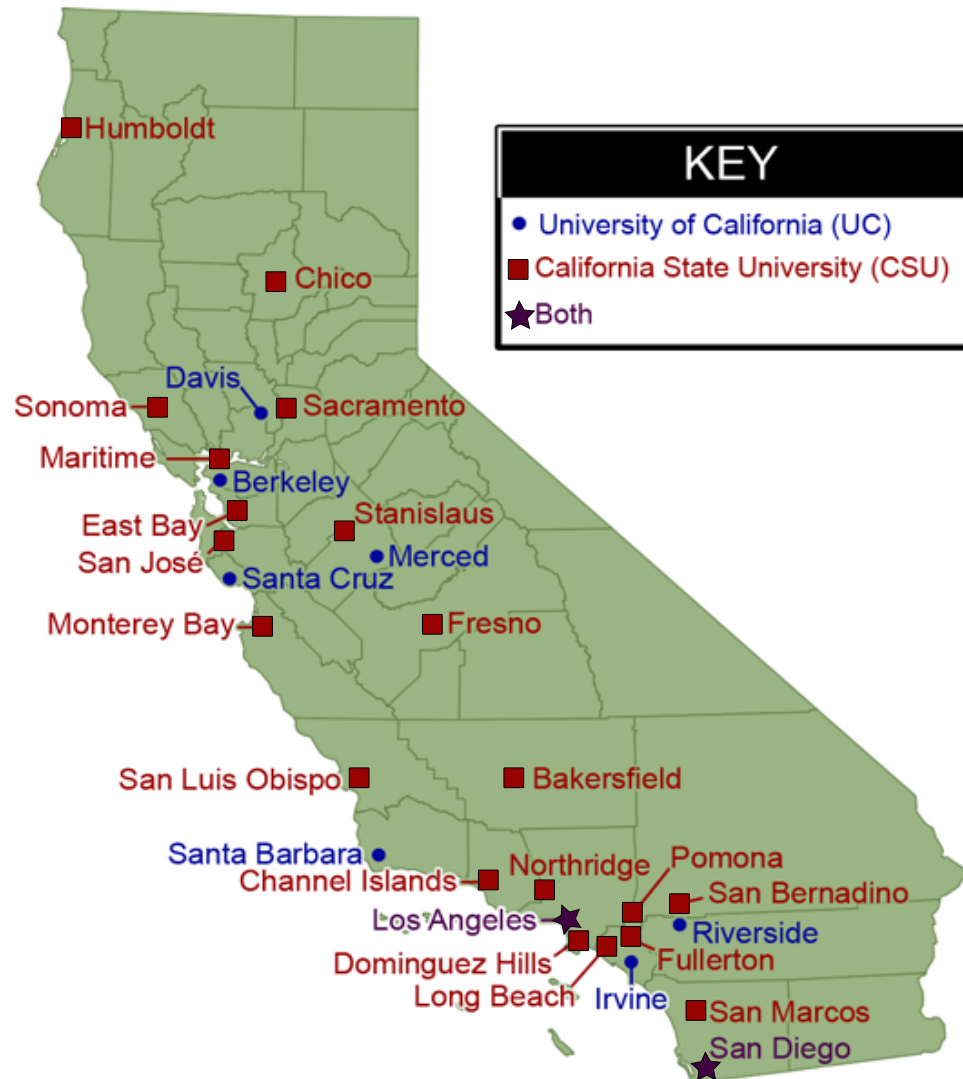
# What is articulation?

Articulation is the process of developing a formal, written agreement that identifies courses (or sequences of courses) on a “sending” campus that are **comparable** to, or **acceptable** in lieu of, specific course requirements at a “receiving” campus.

# The Articulation Process

1. California Community Colleges (CCC) faculty creates a new course or updates the COR and have it go through their college's curriculum process
2. Articulation Office submits COR to CSU and UC for articulation consideration/re-review
3. CSU and UC faculty and/or staff review the COR
4. Decisions are posted in ASSIST.ORG for the students and public to view.



# What is ASSIST?

The official course transfer and articulation system for California's public colleges and universities. Started in 1985 with funding from the California State Legislature.

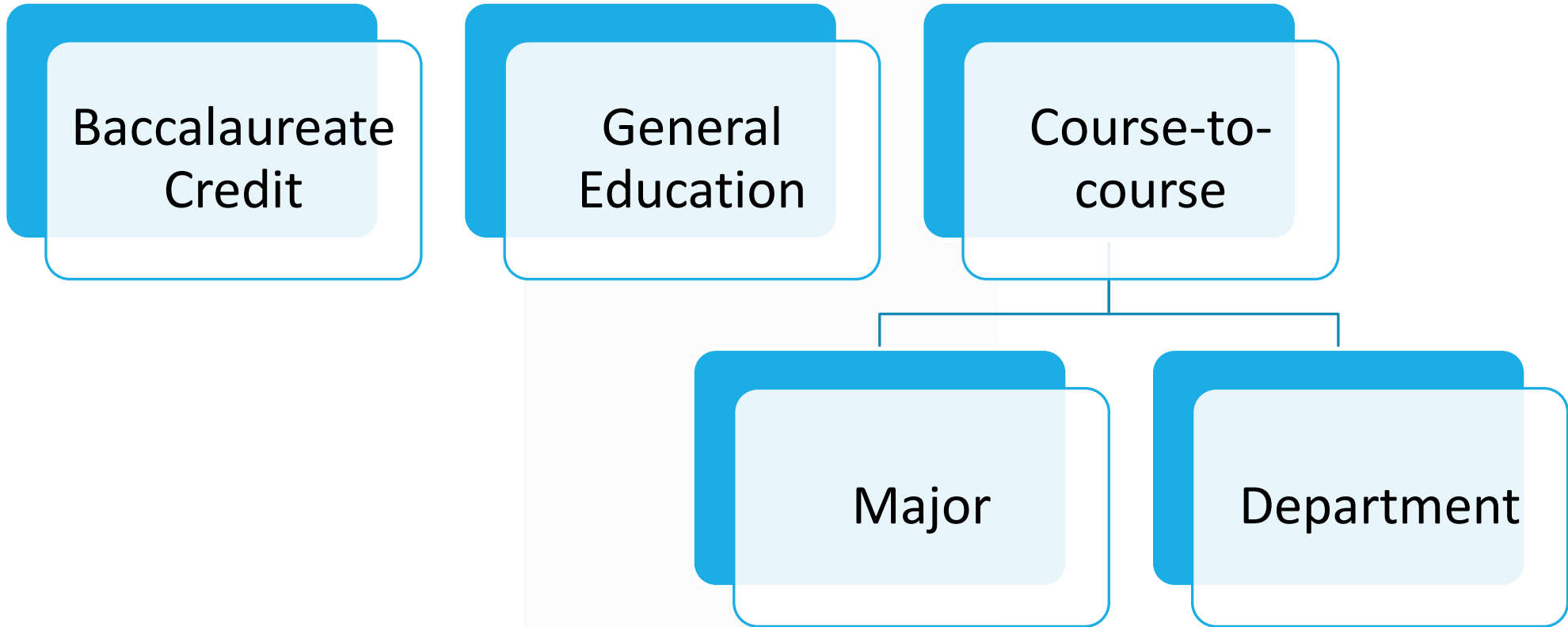

# Before C-ID

- **California Articulation Number (CAN) System (1982-2005)** utilized brief CAN identifiers, a few sentences to describe the content of each course, for common transferable courses as a way to signal comparability, mostly for articulation with transfer institutions
  - Shortcomings: Vague course descriptions, little faculty involvement and review, and lack of continued funding
- **Intersegmental Major Preparation Articulated Curriculum (IMPAC) Project (2000-2006)** utilized intersegmental (CCC, CSU, UC) discipline faculty to identify pre-transfer major prep core curriculum patterns in multiple disciplines, including biology, chemistry, mathematics, and physics
  - Shortcomings: little progress made on descriptors, funding ended in 2006
- **Lower Division Transfer Pattern (LDTP) (2004-2009)** was a CSU effort in response to legislation (SB 1785, Scott, 2004) that was intended to result in transfer pathways that would be accepted to all CSUs. Detailed course descriptors were developed by CSU for each course in a transfer pathway that was required by all CSUs; CCCs could receive a Transfer CSU Number (TCSU) when a course was deemed comparable to the descriptor
  - Shortcomings: not intersegmental, some pathways only had a single course, funding ended

# C-ID Origins



- Faculty-driven supra-numbering system, started in 2007
  - Designed to address the need for common course numbering by assigning course designators (C-ID subject code and number) to significant transfer courses
  - Served as the mechanism to identify comparable courses between colleges based on the common descriptor developed by intersegmental faculty
  - Built on the work done for CAN, IMPAC, and LDTP
- Predates Transfer Model Curricula (TMCs) and Associate Degrees for Transfer (ADTs)
  - After AB 1440 (Padilla, 2010) was passed, C-ID structure and processes were leveraged to facilitate development of TMCs, the template and structure for ADTs

# C-ID Governance



- Intersegmental Curriculum Workgroup (ICW)
- Voting members: Academic Senate for California Community Colleges and Academic Senate of the California State University (ASCCC and ASCSU)-appointed faculty
- Advisory role: System Chancellor's Office partners, articulation officers, faculty from other segments of higher education

# Faculty-Driven System



- Faculty Discipline Review Group (FDRG)
  - Intersegmental: 3 CCC + 3 CSU faculty appointed by respective academic senates. Sometimes UC and AICCU faculty
  - Identify courses needing descriptors
  - Develop descriptors (initial & then final based on feedback from intersegmental vetting of draft descriptors)
- Discipline Input Group (DIG)
  - Implemented in 2011 w/ AB 1440 (ADTs)
  - Open regional events to which all interested discipline faculty are invited to attend
  - Begin the discussion of TMCs and descriptors, which informs the work of FDRGs
- Course Outline of Record Evaluators (CORE)
  - Intersegmental discipline faculty who review submitted CORs against descriptors

# C-ID Descriptors



- **Descriptors** for individual courses or sequence set minimum standard for determination of courses as comparable
  - General Description (not part of CORE review)
  - Units
  - Prerequisite(s), Co-Requisites, Advisories
  - Content
  - Lab Activities (when applicable)
  - Objectives (title 5)
  - Methods of Evaluation
  - Sample Textbooks
- Courses reviewed for determination of comparable, not identical
- Descriptor designations (subject code and number) do not replace local course numbering but should be listed alongside it in college publications
- Vetted broadly via intersegmental discipline-specific listservs
- Reviewed every 5 years

# C-ID Descriptors



- By the numbers
  - 57 disciplines with descriptors (15 CCC only)
  - 464 finalized descriptors
- Course Outlines of Record (CORs) reviewed for determination of comparable, not identical
- Descriptor designations (subject code and number) do not replace local course numbering but should be listed alongside it in college publications
- Vetted broadly via intersegmental discipline-specific listservs
- Reviewed every 5 years; out-of-cycle reviews can be conducted at request of FDRG
  - Lead to address emerging issues that would negatively affect students

# C-ID Descriptor Development



- DIGs are held to solicit input from all interested discipline faculty from CCC, CSU, and UC
  - Traditionally, north & south regional meetings
  - DIGs take input and begin developing draft descriptors
- FDRG, including FDRG Lead, consolidate DIG input and descriptor drafts into finalized draft descriptors
- Finalized draft descriptors are vetted for review and comment via C-ID website. Messaging via discipline listservs and within CCC, CSU, and UC systems notifies faculty of opportunity for review
- All comments, questions, and suggestions are forwarded to FDRG Lead and FDRG, who determine what, if any, revisions need to be made. Final descriptors are submitted to C-ID for review and acceptance by C-ID Advisory and ICW
- Final descriptors are published on C-ID website



# C-ID COR Submission Processes

- Once final descriptors are published on C-ID website, articulation officers work with local college faculty to review local COR alignment to descriptors and prepare to submit revised courses for local curriculum approval and, after, for C-ID articulation
- Local college articulation officers submit CORs for review via C-ID website



# C-ID COR Submission Processes



- Submission to C-ID begins the peer review process
  - Primary Reviewer (CCC) assigns COR to 2 discipline faculty COREs: 1 CCC, 1 CSU
  - COREs review COR independently and recommend 1 of 3 possible determinations: approved, conditionally approved, or not approved for C-ID designation. Specific feedback for determination must be provided by each CORE
- Faculty or AO who disagree with Conditional or Not Approved findings can appeal and request another review

# C-ID and Articulation



- Colleges with an approved C-ID designator must accept other college courses with the same approval
- Receiving institutions (CSU, UC, AICCU, HBCU, etc.) can articulate to a single C-ID descriptor and may have that articulation apply to courses deemed comparable

# Associate Degree for Transfer

- In 2010 the California Legislature passed SB 1440 (Padilla), a Senate Bill that authorized California community colleges to create associate degrees for transfer that would guarantee students admission into the CSU system.
- These degrees must be composed of no more than 60 transferable units, including a general education plan for transfer (IGETC or CSU Breadth) and a minimum of 18 units in a major or area of emphasis.
- The legislation provides that students who successfully complete these degrees will receive guaranteed admission with junior status into the CSU system and students would only need to complete the remaining 60 units at the CSU campus to graduate.
- To facilitate the development of the transfer degrees and to ensure their statewide applicability, the Academic Senate developed “Transfer Model Curriculum” (TMC) that would fulfill the required 18 semester unit minimum of major preparation for each discipline.

# Transfer Model Curriculum



- TMCs are a template developed by intersegmental faculty for the required and elective major components of an Associate Degree for Transfer (ADT)
- TMC functions as the statewide consensus among intersegmental discipline faculty on the lower division requirements of major
- Required courses in TMC are typically identified by C-ID designations
  - When a designator is not available for a course that it is agreed should be in a TMC, specific info re: GE or Major Prep articulation must be included
- 47 TMCs currently

Attach the appropriate ASSIST documentation as follows:

- *Articulation Agreement by Major (AAM)* demonstrating lower division preparation in the major at a CSU;

- *CSU GE Certification Course List by Area (GECC)*.

# Recap of AB 1111 Charge

- 66725.5. (a) (1) To **streamline transfer from two- to four-year postsecondary educational institutions** and reduce excess credit accumulation, on or before July 1, 2024, both of the following shall occur:
  - (A) **The California Community Colleges shall adopt a common course numbering system for all general education requirement courses and transfer pathway courses.**
  - (B) Each community college campus shall incorporate common course numbers from the adopted common course numbering system in its catalog.
- (2) The common course numbering system shall be **student facing**, based on the work of the workgroup established in Item 6870-101-0001 of Section 2.00 of the Budget Act of 2021, and ensure that **comparable courses across all community colleges have the same course number.**
- (3) To support the development and implementation of a common course numbering system for the California Community College system, **the workgroup** established in Item 6870-101-0001 of Section 2.00 of the Budget Act of 2021 **shall consider starting with courses included in the Course Identification Numbering System (C-ID) and expanding to general education requirements and transfer pathway courses** pursuant to subdivision (b).
  - (b) The common course numbering system may have the same alphabetical identifier and same numerical identifier for each course that shares the same C-ID course description, pursuant to both of the following:
    - (1) For all courses included in the C-ID, the California Community Colleges may adopt the alphabetical and numerical identifier of the C-ID course descriptor as the same common course number at all community colleges.
    - (2) **For all general education requirements and transfer pathway courses that are not included in the C-ID**, intersegmental discipline **faculty** through the C-ID process **may develop a C-ID course descriptor** for each of these community college courses. Once a C-ID course descriptor is developed, the California Community Colleges may adopt the alphabetical and numerical identifier of the C-ID course descriptor as the same common course number at all community colleges.
