Education Code 66725

- Assembly Bill 1111 (Berman, 2021) established the following:
- "(a) (1) To streamline transfer from two- to four-year postsecondary educational institutions and reduce excess credit accumulation, on or before July 1, 2024 (2027)*, both of the following shall occur:
 - (A) The California Community Colleges shall adopt a common course numbering system for all general education requirement courses and transfer pathway courses.
 - (B) Each community college campus shall incorporate common course numbers from the adopted common course numbering system in its catalog.
 - (2) The common course numbering system shall be student facing... and ensure that comparable courses across all community colleges have the same course number."

CCN Implementation Funding

Higher Education Trailer Bill, 2021-22

- \$ 105,000,000 appropriation
- Assist with the adoption of and transition to a common course numbering system
- May be used for but not limited to:
 - Aligning existing course curricula to a common course numbering system
 - Updating course catalogs and other digital course registries
 - Supporting faculty costs associated with course differentiation and curriculum approval
 - Campus communication efforts to inform students of revised course numbers and curricula

Allocation to Colleges

- \$ 913,043 to 115 colleges
- Disbursed through Apportionment
- Required reports
 - Standard MIS term data
 - Annual Survey due



Phased Implementation Goals

The CCN Task Force proposed a phased approach to Implement CCN

- Phase I (2024-2025) 6 Course Templates finalized
 - Faculty work in collaboration with intersegmental leadership teams to develop CCN
 Templates for fall 2025 implementation Descriptors for an initial set of high-enrollment courses
 to generate an initial set of CCN-aligned courses for fall 2025.
- Phase II (2024-2025) approximately 20 courses finalized by faculty Fall 2024
 - Second cluster of courses.
 - Evaluate and refine the development processes and template.
 - Test technology-based implementation.
 - Validate intersegmental collaboration.
- Phase III (2026-2027) approximately 50 courses finalized by faculty Spring 2025
 - Implement potential technology solutions and roll out the remaining transfer courses.
- Taxonomy was released in early September 2024
- Funding to Colleges (\$913,043) September



What does this mean for colleges?

The following information and suggestions are provided for colleges as they work to implement solutions for common course numbering:

- Colleges are encouraged to work collaboratively through local structures to:
 - Complete local curriculum work and submit the 6 courses to COCI by December 2, 2024
 - Implement Phase I CCN courses to be student-facing by Fall 2025 and in the 2025-26 catalog
 - Identify all technical systems that will be impacted by CCN
 - Prioritize needed changes to systems
 - Develop local timelines to implement those changes
- Downstream and ancillary systems will also need to be updated and may require more time - deadline is Fall 2027 for all technology solutions to be in place
- Colleges will need to provide training and ongoing support for staff, faculty and students on navigating updated systems
- Colleges will need to ensure data integrity associated with CCN



Actions to Advance the Vision

CCN Next Steps

- Advocate for sustainability funding to support technological changes
- Build and continue partnerships with the local 4-year partners
- Remove barriers for articulation
- Ensure roll-out is streamlined
- Make communication
 student-facing and simple
