California Apprenticeship Initiative (CAI)

Accurate use of SAM course codes (e.g., CB09 = A for apprenticeship courses) and correct student apprenticeship status coding (SB23) is essential for reliable statewide reporting, compliance with funding rules, and proper alignment with DAS registration requirements. Misclassification can lead to reporting errors, missed funding opportunities, and challenges in measuring program outcomes.

Perkins V

- **Reminder Regarding Prohibited Use of Federal Grants Funds for Lobbying and Allowable Membership Costs.**
 - Under the Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards (commonly referred to as the Uniform Guidance), lobbying costs are unallowable charges to a federal award. Specifically, 2 C.F.R. § 200.450 prohibits the use of grant funds for lobbying activities, including influencing activities associated with obtaining grants or attempting to influence, either directly or indirectly, an employee or officer of the executive branch of the Federal Government to give consideration or to act regarding a Federal award or a regulatory matter.  - **Consequences for Noncompliance:** Failure to comply with these provisions may result in disallowed costs, audit findings, program reviews, and additional oversight or enforcement actions by the Department up to the termination of your grant.
- **Perkins Headcount report 1 & 2 for Local Allocation of Funds, FY 2026–27**
 - Statewide Perkins participation reached 631,055 students in FY 2026–27, the highest level in six years and exceeding pre-pandemic enrollment benchmarks.
 - As California’s 116 community colleges continue to serve roughly 2.5 million students, nearly half (47%) of California community college students enroll in CTE across 16 career clusters, with Perkins funds supporting a significant share of economically disadvantaged learners.
 - Reports 1 & 2 will be available as an attachment with memo announcing the FY 2026–27 Perkins IC application.
- **Title I-C Local Assistance**
 - Q3 Reporting is **due April 15**.
A note to all districts: Failure to submit quarterly reporting in a timely manner will cause delay in receiving reimbursement and may result in a Perkins funding **risk assessment**. The district should reach out to **regional monitor** regarding any questions and/or concerns regarding this submission date.
