- CSEA echoed inquiry about the BDP Cycle Two applications.
- FACCC voiced support of the BDP.
- CCCAOE voiced support of the BDP.

# Digest Item 1.6: The Future of Teaching, Learning and Student Success (Vice Chancellor Finche)

This digest item initiated a systemwide conversation on the future of teaching, learning, and equitable student success, the factors that contribute to equitable student success in and outside the classroom, and consideration of how to support faculty, counselor, and librarians in advancing equitable student success.

### **Discussion Summary:**

- CSEA inquired about exclusions in the Faculty Obligation Number (FON).
- CCA/CTA expressed concerns with the FON measuring process.
- FACCC expressed concerns with the audit report recommendations.
- CCCCIO highlighted student success and full-time faculty.
- CCCI echoed CCA/CTA's and FACCC's concerns and requested discussion of all audit recommendations.
- CCA/CTA suggested developing a measurable goal and plan.
- CO highlighted the Vision for Success core commitments.

## Digest Item 1.7: Inclusive Consultation Council Membership

#### (Interim Chancellor Gonzales and General Counsel LeForestier)

The Chancellor's Office sought to engage in consultation regarding requests to expand the membership of the California Community Colleges Consultation Council in an effort to become more inclusive and advance student-centered design.

- SSCCC inquired about the RP Group's connection to student advocacy.
- CCCCIO voiced support for 4CS membership inclusion on the Council and expressed concerns for the RP Group's membership inclusion.
- CCCT voiced support for 4CS membership inclusion on the Council.
- CCC/CFT voiced opposition against additions to Council membership.
- CCA/CTA expressed concerns with additions to Council membership.
- CCLC raised concerns about potential competitive advantages with the RP Group.
- CCCT voiced support for the inclusion of classified professionals.
- CCE/CFT voiced opposition against additions to Council membership.
