Discussion Summary:

- FACCC inquired about the funding for the Demonstration Projects and requested clarification about the distinction between Cradle to Career and Common Cloud data platforms.
- CCA/CTA commended the work on this digest item and raised discussion on evaluating the outcomes and sustainability of the Demonstration Projects.
- ASCCC encouraged assessment evaluation and governance around evaluation and policy points.

Digest Item 1.6: 2025-26 Proposed State Budget Update

(Executive Vice Chancellor Ferguson and Vice Chancellor O'Brien)

This digest item provided an update on the Governor's 2025-26 Budget Proposal.

Discussion Summary:

- ACBO encouraged a budget allocation framework to support state costs to support initiatives.
- CCLC raised concerns about funding for statewide goals and initiatives.
- CSEA echoed CCLC about funding concerns for statewide goals and initiatives.
- ACCCA echoed CSEA about concerns with funding growth.

Digest Item 1.7: California Career Education Master Plan Update

(Chancellor Christian, Vice Chancellor Cordova and Executive Vice Chancellor Ferguson)

This digest item provided the Consultation Council with an overview of the California Career Education Master Plan.

Discussion Summary:

- CCCI commended the work of this digest item and inquired about Associate Degree for Transfer (ADT) placements.
- ASCCC shared insight on Associate Degree for Transfer (ADT) placements.
- CCA/CTA inquired about the Course Outline of Record (COR) and expressed concern about hiring more Career Technical Education (CTE) instructors owing to upcoming retirements.
- CSEA inquired about the demographic changes of more women in the community college system compared to men.
- FACCC commented about the demographic changes of community college attendance between women and men.
- SSCCC inquired about the demographic of men comprising more of the CTE programs compared to women.
- FACCC requested additional information about CTE and Strong Workforce programs.
- CSEA inquired about community-based partnerships in terms of outreach and engagement.
- CCCAOE inquired about the use of Department of Labor funds.
- CCA/CTA inquired about the specific industries included under CTE.

Digest Item 1.8: Other

(Deputy Chancellor Tomaneng)

This digest item provided members of the Council an opportunity to make announcements or seek collaborations that will help our system better serve students.

Discussion Summary:

- CCA/CTA raised discussion on part-time healthcare.
- FACCC inquired about the final statewide budget request.

- SSCCC shared insight that faculty working conditions are students' learning conditions.
- CSEA requested discussion on the California wildfires.
