Discussion Summary:

Digest Item 1.3: Vision 2030: A Roadmap for California Community Colleges, The July 2025 Edition

(Visiting Executive May)

This digest item provided Consultation Council with an revisions on Vision 2030 including revisions to the Goals and Actions, changes in measurable outcomes, and the development of the Vision 2030 microsite.

Discussion Summary:

- FACCC expressed gratitude for addressing the concerns that FACCC had raised regarding revisions to Vision 2030.
- CCA/CTA expressed gratitude for addressing feedback that CCA/CTA had expressed.
 Requested that future revisions include shared governance that includes faculty and the needs of equity for the educators in the system.
- CEOCCC mentioned that changes at the federal level can have an impact on colleges' ability to implement Vision 2030.

Digest Item 1.4: Current State Budget, 2026-27 Shared Advocacy Request, and Legislative Update

(Executive Vice Chancellor Ferguson, Assistant Vice Chancellor Vazquez)
This digest item provided Consultation Council with an update on the current state budget and the implications for California Community Colleges, as well as updates on the forthcoming 2026-27 Shared Advocacy Request process and an update on State and Federal policy issues, advocacy priorities, and legislation.

Discussion Summary:

- FACCC sought clarification on Medicaid eligibility.
- CCA/CTA sought clarification on a legislative bill's status in the California State Legislature.
- ACBO sought clarification on shared advocacy request.
- CCLC sought clarification on Pell Grant eligibility and how students who have the Board of Governors Fee Waiver or other scholarships could potentially lose eligibility for the Pell Grant.

- CEOCCC asked about what Prop 98 funding looks like for the upcoming fiscal year.
- ACBO and CEOCCC also commented on federal changes impact on funding and strategies to lessen negative impacts and the colleges as well as prioritize programs with bipartisan support.

Digest Item 1.5: Other

(Deputy Chancellor Tomaneng)

This digest item provided members of the Council an opportunity to make announcements or seek collaborations that will help our system better serve students.

Discussion Summary:

SSCCC discussed burden free learning materials and the importance it has for students.
