AGENDA DIGEST ITEMS

Digest Item 1.1: Chancellor's Office Update

(Chancellor Christian)

The Chancellor's Office presented updates on relevant developments and time-sensitive changes since the previous Consultation Council meeting, as well as digest items previously presented that may require additional consultation.

Discussion Summary:

Digest Item 1.2: Student Senate Update

(SSCCC President Reyes and VPLA Nagpal)

This digest item presented updates on the SSCCC current initiatives, legislative stances, system participation, and the status of the SSCCC Board of Directors.

Digest Item 1.3: Proposed Regulatory Action: Alternative Methods of Awarding Credit

(Vice Chancellor Todd and Visiting Executive Ginni May)

This digest item presented proposed regulatory changes to Title 5 regarding alternative methods of awarding credit.

Discussion Summary:

- CCCAOE requested clarification on Section 55050, subsection (b) regarding student portfolios, now referred to as authenticated competencies. The Chancellor's Office confirmed that portfolios would not be excluded.
- FACCC asked about Section 55052, External Standardized Examinations, specifically the Defense Language Proficiency Test and instructor training. The Chancellor's Office clarified that districts may accept this test for credit; however, no statewide training is planned.
- ASCCC inquired about Section 55052, subsection (a) and its impact on transferability. The Chancellor's Office clarified that the provision applies to community college degrees only and does not affect transfer to CSU or UC.

Digest Item 1.4: Full Time Faculty Obligation Number

(Executive Vice Chancellor Ferguson)

This item provided information to the Consultation Council related to the Board of Governors' review of whether the Budget Act of 2025 provides adequate funding to support an increase in districts' full-time faculty hiring obligation for Fall 2026.

Discussion Summary:

• CCC/CFT asked about the replacement cost a district would incur if it does not meet the Full-Time Faculty Obligation (FON).

Digest Item 1.5: State and Federal Update

(Vice Chancellor O'Brien and Assistant Vice Chancellor Vazquez)

This digest item provided Consultation Council with an update on state and federal efforts.

Discussion Summary:

- CCCAOE asked when the Chancellor's Office guidance on Assembly Bill (AB) 323 and whether the changes to short-term Pell Grants would be provided. The Chancellor's Office stated that guidance is forthcoming.
- CSEA asked about AB 1098, Senate Bill (SB) 638, and the addition of Diwali to the state holidays list. The Chancellor's Office explained that the Governor's signature indicates support for intersegmental collaboration and noted that Diwali will take effect next year, with districts able to adopt it voluntarily.
- CCLC asked whether guidance on implementing SB 98 will be provided. The Chancellor's Office stated guidance is forthcoming, though no timeline is established.
- FACCC highlighted its sponsorship of SB 241, which would require certain student support services to be provided by humans rather than artificial intelligence.
- CEOCCC suggested any nursing bachelor's degree legislation should be approached regionally rather than statewide, as some regions may lack partnerships with CSUs or UCs.

Digest Item 1.6: Other

(Deputy Chancellor Tomaneng)

This digest item provided members of the Council with an opportunity to make announcements or seek collaborations that will help our system better serve students.

Discussion Summary:

 CCCCIO requested an update on pending Baccalaureate Degree Programs, including report receipt and a projected timeline. The Chancellor's Office confirmed that all reports have been received except for one program still under review and noted that establishing a timeline is difficult due to steps requiring action from external parties.

- CCLC expressed concern that the current process lacks transparency and favors
 institutional impact over statewide need and requested legislative changes. The
 Chancellor's Office explained the causes of the delays and committed to sharing
 information as it becomes available.
- CCLC requested that updates on the Baccalaureate Degree Program become a standing agenda item, which was supported by CCCCIO.
- CCC/CFT raised concerns about Element 451 and the AI Fellowship Program's potential job impacts, noting that the program had not been previously discussed at the Consultation Council, and requested that these items be addressed at the next meeting.
