Digest Item 1.2: Chancellor's Office Update

- CCA/CTA expressed concerns with potential drop-out rates of immigrant students.

This digest item presented updates on the SSSCC current initiatives, legislative stances, system participation, and the status of the SSSCC Board of Directors.

Digest Item 1.4: Vision-Aligned Reporting Overview

(Vice Chancellor Cooper and Assistant Vice Chancellor Browne)

This digest item presented the Vision-Aligned Reporting as a new process for California Community Colleges to collect and report data that focuses only on information that offers direct visibility to drive cross-functional conversations about how programs can work together to better leverage resources, address equity gaps, and increase equitable student outcomes.

Discussion Summary:

- SSSCC commended the work on this digest item and inquired about data collection processes.

Digest Item 1.5: AB 705 Success Stories: Empowering Students Through Equitable Access to Higher Education

(Vice Chancellors Stankas and Cooper)

This digest item underscored the impact of Assembly Bill (AB) 705, illustrating how equitable access to transfer-level courses in mathematics and English enhances student empowerment and outcomes.

Discussion Summary:

- CSEA inquired about military students.
- CCA/CTA commented about work on equity gaps at the college-level.
- SSSCC advocated for student choice in terms of selecting pretransfer-level or transfer-level courses.
- CSSO raised discussion about realigning practices in and out of the classrooms.
- FACCC raised discussion about data surrounding equity gaps.
- CCE/CFT raised discussion about engagement.
- SSSCC expressed concerns about dismissiveness about the student voice.
- CCA/CTA raised discussion about equity gaps surrounding mathematics.

Digest Item 1.6: Launching the Statewide Data Governance Advisory Workgroup

(Executive Vice Chancellor Hetts)

This digest item provided an update on the launching of the new Data Governance Advisory Group (DGAW) to help the system tackle critical questions of how to store, manage, secure, use, and share data across statewide technology and data transformation efforts starting with a summary of the first meeting.

Discussion Summary:

- CCCI inquired about the lack of union representation on the workgroup.
- SSSCC inquired about the use of data collection as it relates to undocumented students.
- CCCCIO inquired about the lack of CSOA representation on Consultation Council.

(Executive Vice Chancellor Hetts and Visiting Executive Hayward)
