The California Community Colleges Chancellor's Office is pleased to announce the release of the Letter of Intent (LOI) for the Associate Degree in Nursing/Registered Nurse programs. This LOI will serve as the Request for Applications. The purpose of the LOI is to solicit and identify community college districts wishing to participate in the expansion of student nursing program cohorts, reduce attrition, and increase completion. Based on the LOIs submitted to the Chancellor's Office, grant funding will be issued to colleges under a new funding formula.

Nursing Program Funding

A goal of the Chancellor's Office is to gradually adjust the allocation formula to be in full compliance by 2028 [Education Code Section 78261]. Colleges and programs will have time to adapt their practices to meet the requirements of the new allocation structure. The funding formula transition places colleges into one of two categories, based on the nursing program's outcomes data provided to the Chancellor's Office by colleges for the past six years. The categories are:

- 1. **Retention** any program which has a demonstrated need to address its program completion status will be required to spend their allocation to address this issue.¹
- Growth any program that does not have issues with attrition or equity will be invited to grow their program by from one to three cohorts. A cohort is defined as a group of a minimum of eight students.²

Chancellor's Office, Workforce and Economic Development Division

Funds may not be used by community college districts to supplant existing courses but shall be used to enable more students to successfully complete the course of study or expand enrollments, depending on the above-referenced categories in which the Chancellor's Office has placed the college. Successful applicants should be ready to implement the requirements of these specifications as soon as the funds are available. The grant duration is for two years (24 months) and is expected to run July 1, 2023, to June 30, 2025.

Letter of Intent Submission

A Letter of Intent to Apply is required. The LOI signed by the authorized district/college signatories, written responses, and budget estimate must be submitted via to the Chancellor's Office NOVA system by **June 22, 2023, by 5:00 P.M**.

To be awarded, complete the application and submit a Letter of Intent in NOVA. Once the applications have been submitted in NOVA, the Chancellor's Office will make the final determinations of award amounts based on the requests received. At that time, applicants will be asked to enter a workplan and revised budget.

Exhibit A – FY 2023-2024 Regions and Allocations

Retention Campuses:

Colleges with a demonstrated need to address its programs completion outcomes will be required to spend their allocation to address attrition. [Education Code Section 78261(d)(1)]

1. Note: The Retention allocation is calculated based on the average number of students enrolled in the nursing program at the college receiving funding for the past three years x \$2,430.00 per student. As a result of the Chancellor's Office commitment to not reduce any program's funding by more than 15 percent, protections were put into place to ensure minimal impact to colleges. Therefore, some Retention colleges will receive more than the base of \$2,430.00 per student in FY 2023-2024 to ease transition to this new allocation formula.

Growth Campuses:

Colleges that do not have issues with retention will be invited to grow their program by from one to three cohorts. [Education Code Section 78261(b) and (d).

Note: A cohort will be defined as a group of a minimum of eight (8) students to be funded for two (2) full years from the current year's funding. The base allocation is \$91,200 per cohort. Some campuses may show an excess of funding above the amounts described here. To reduce the disruption of current nursing program fundings, campuses will not experience a cut of higher than 15 percent of its prior year's allocation.
