RE: Amended Notice of Intent to Award - California Apprenticeship Initiative New and Innovative Grant Program (Fiscal Year 2023-24)

This memorandum serves as formal notification of the Amended Notice of Intent to Award for the California Apprenticeship Initiative New and Innovative Grant Program for fiscal year 2023-24. (CAI Program or Program). An initial Notice of Intent to Award was posted on the Chancellor's Office website on March 7, 2024, and the Chancellor's Office received appeals regarding the scoring rubric used to evaluate the applications. After considering the appeals, the Chancellor's Office elected to rescore all of the planning grant applications in two ways: (1) If applicable, additional points (as described below) for an apprenticeship program that would provide community college credit to apprentices and/or lead to a community college degree were included in the scoring, and (2) a score of 75 points was applied for meeting the Request for Application (RFA) requirements (the original scores were based on an 80-point scale). The result of the rescoring is that several applications that were not funded in the March 7, 2024 Notice of Intent to Award will now be funded, and other applications that were previously announced to be awarded will now not be awarded at this time.

The Chancellor's Office deeply appreciates and acknowledges the efforts of all applicants in this CAI Program application round. The Office received 210 applications requesting more than \$103 million in Program funding. The Chancellor's Office is unable to fund all of the applications due to funding limitations in the budget bill for the Program. However, the Chancellor's Office intends on allocating Program funding from fiscal year 2024-25 to applicants that did not receive funding in this round.

Grant Awards

The CAI Program supports new and innovative apprenticeship opportunities in priority and emerging industry sectors or areas. Grant awards are based on amounts requested in the grant applications with the following caps for each type of grant: (1) Apprenticeship Program Implementation - \$1,500,000; (2) Apprenticeship Program Expansion - \$1,000,000; (3) Pre-Apprenticeship Implementation - \$500,000; and (4) Planning - \$120,000.

Points were first awarded to applicants based on three categories: (1) RFA Requirements; (2) Occupation Proportion of Regional Labor Market Demand; and (3) Cost per Apprentice or Pre-Apprentice and were calculated as follows:

1. **RFA Requirements (RFA Score):** Each application was reviewed to determine whether the content of the application met the RFA requirements. If it did, the application was awarded 75 points. If the application did not meet the RFA requirements, it received 0 points for this factor.
2. **Occupation Proportion of Regional Labor Market Demand (RLMD Score):** In order to calculate the RLMD Score, the primary occupation included within each application was first identified. If an application included multiple primary occupations, the first occupation cited was used as the primary occupation. The Labor Market Information resource tool (LMI Tool), identified in the RFA, was used to evaluate the RLMD. The Annual Job Openings for the primary occupation within the region identified in the application was compared to the LMI Tool. If the primary occupation did not align to the LMI Tool, the closest comparable occupation in the LMI Tool was used. The Annual Job Openings for the occupation was divided by the Annual Job Openings for the region, and a LMI Base Score was established. The LMI Base Scores were ranked largest to smallest within each grant purpose grouping. For each grouping, the application with the greatest LMI Base Score was awarded up to 15 or 25 points, depending on the grant purpose. The remaining applications received a score in proportion to their LMI Base Score divided by the largest LMI Base Score in that grouping (see chart below as illustration).

2. **Cost per Apprentice or Pre-Apprentice (Cost Score) [Not applicable to Planning Grants]:** This score was calculated by dividing the number of apprentices or pre-apprentices that an applicant plans on registering with the Division of Apprenticeship Standards during the grant performance period by the total budget cost of the application. This number was then ranked smallest to largest within each grant purpose grouping. For each grouping, the application with the smallest average cost per apprentice or pre-apprentice was awarded 10 points. The difference between the smallest average cost per apprentice or pre-apprentice and the expected outcome average cost included in the RFA [either \$2,500 per pre-apprentice or \$15,000 per apprentice] was used to find the Group Cost Range. The remaining applications received 9 through 0 points depending on where their average cost per apprentice or pre-apprentice fell within the Group Cost Range (see chart below as illustration).

An additional 5 points was awarded to applications that indicated apprentices would receive community college credit, and another 5 points to applications where the apprenticeship program resulted or directly tied into a degree. And applications for programs supported by a previous CAI planning grant were prioritized.

The Chancellor’s Office totaled all of these points to establish a final score, ranked all applications by their final score regardless of grant purpose, largest to smallest, and awarded to as many applications in rank order as funding permitted. The overall scoring for each grant application category is outlined in Table 1 through Table 4 below. The legend for the tables is as follows:

- **Funded:** indicates applicants that met the requirements of the request for application and that were ranked high enough to receive a grant award.
- **Not Funded:** indicates applicants that met the requirements of the RFA but that did not rank high enough to receive a grant award.
- **Ineligible:** indicates applicants did not meet the requirements of the RFA. A reason is noted.
- Occupations with an **asterisk symbol** indicate applications that were continuations of previous CAI planning grants, and that were prioritized for award.

Table 5 includes grant scoring details for all applications and is presented in alphabetical order by grantee.

Appeals

Applicants have ten (10) business days from the day this memorandum is distributed and posted online to submit an appeal. If an appeal is submitted during this period, the grants affected will not be awarded until the appeal is resolved. The appeal must specify the grounds of appeal and must be based on the process and/or procedures used in the review and recommendation of application for awards. The appeal must be emailed with an email header of “CAI Appeal: TIME SENSITIVE” and addressed to the Dean of the program responsible for funding the project: GAdams@CCCCO.edu.

Next Steps

Upon expiration of the time to file an appeal or after all appeals are resolved, the Chancellor’s Office will issue a notice of award. Before the grant agreements are executed, they must be approved by the

Board of Governors. The Chancellor's Office anticipates that the grant awards will be submitted to the Board at its July 2024 meeting. Prior to execution of grant agreements, Chancellor's Office staff may contact grantees to request adjustments or modifications to the work plan and/or budget submitted as part of the grant application.
