RE: Middle College High School Grant Intent to Award Fiscal Years 2023-24 through 2025-26

The California Community Colleges Chancellor's Office, Division of Educational Services and Support, is pleased to announce award grant funding for 2023-24 through 2025-26 to support Middle College High School (MCHS) programs for California Community Colleges. In addition to 2023-24, 2024-25 and 2025-26 funds, grantees will also receive reappropriated funds from 2016-17 and 2018-19. A comprehensive list of awardees and funding details can be found in Table 1. Funds were evenly distributed to college districts/colleges based on their intent to continue the MCHS program, as certified online by grantees from 2020-21.

Middle College High Schools were established pursuant to Education Code Section 11300. Middle College High Schools have proven to be a highly effective collaborative effort between local school districts and community colleges. The goal of the program is to select at-promise high school pupils who are performing below their academic potential and place them in an alternative high school located on a community college campus to reduce the likelihood they will drop out of school prior to graduation.

Grant awards will advance Vision 2030 by promoting equity in success, access and support. Additionally, MCHS programs aim to reduce high school dropout rates by enhancing academic performance and enrolling at-promise high school students in courses necessary for a high school diploma or applicable towards an Associate of Arts (AA)/Associates of Science (AS), AA-Transfer/AS-Transfer, vocational certificate, or transfer preparation.

Each eligible college district MCHS Project Director will receive a formal email notification containing grant award details and instructions for their grant award.
