## Map Data Sources

- · California Community Colleges Chancellor's Office
- Department of Health Care Access and Information
  - Hospital Data: 2022 Hospital Annual Utilization (Revised 11/28/2023). Note:
     2023 Data file was not published at time of initial data request.
  - RN Shortage Data: HCAI's Nursing Supply & Demand Model for the RN role group, 2024. *Note: This data is not yet publicly available.*
- Population Data: US Census Bureau County Population Totals and Components of Change: 2020-2023



#### Nursing Shortage Score & Shading

#### **Purpose**

 Identify counties with a high nursing shortage.

#### **Approach**

- Data from HCAI
- Nursing gap per 100,000 individuals
- Rated on a scale from 0 to 5

Score	Shade	Gap per 100,000 Population
0		No Gap or Surplus
1		Gap -13.82 to 0
2		Gap -65.76 to -13.83
3		Gap -150.7 to -65.77
4		Gap -279.18 to -150.71
5		Gap more than -279.18

#### **Approach**

- Squares for main campuses.
- Triangles for campus centers or satellite campuses.

# California Community Colleges with ADN Nursing Programs

#### **Purpose**

 Differentiate colleges with Associate Degree in Nursing programs.

#### **Approach**

- Gold markers for colleges that have an ADN program at one of their campuses.
- **Black** markers for colleges that do not have an ADN program at any of their campuses.

#### **Using Map Data**

Community

The map can support answering the following questions:

- What is the nursing gap score in nearby counties?
- Do students from nearby counties with nursing shortages matriculate in the ADN program?
- Do ADN students from your program complete clinical rotations in nearby counties with nursing shortages?
- How can you tell if a county where a campus is located doesn't have a high nursing gap score?

# Rebuilding Nursing Infrastructure(RNI) Program Grant Opportunity

## Background

- California faces a critical shortage of registered nurses. Due to healthcare demands, the state will need 44,500 registered nurses by 2030.
- The Budget Act of FY 2024-25 allocated funds for community colleges to bolster nursing education and training in California. Ed. Code, § 88770, et seq.; Stats. 2024, ch. 71 (SB 155).
- \$60M from Strong Workforce Program will be used for grants and technical assistance to colleges to support the Rebuilding Nursing Infrastructure (RNI) Grant Program.



# Grant Purpose and Goals

The RNI Grant Program will:





Expand nursing programs and partnerships

Address nursing shortages

Increase, educate, and maintain the next generation of Registered Nurses

## Eligibility

- Eligible Applicants for funding are California Community College districts.
- Multi-college districts must submit one separate application for each college within the district seeking funding.



## **Funding Purposes**

## **From Education Code Section** 88772(b)

- There are 8 legislative purposes for the RNI grant program.
- Funding for the program will be awarded for any one or combination of the listed purposes.
- Here we review the first three purposes.

- 1. Developing or expanding bachelor of science in nursing partnerships, including established partnerships with the California State University, the University of California, or independent institutions of higher education.
- 2. Developing or expanding associate degree in nursing programs.
- 3. Developing strategies for recruiting, retaining, and training high-quality nursing faculty.



#### Available Funds

- The successful Applicants will be awarded a grant of up to \$2,000,000 per college.
- \$57,000,000 available funds for this application round.
  - \$3,000,000 for Chancellor's Office admin costs & technical assistance.

- The Chancellor's Office shall determine the amount of each grant for a recipient, taking the following factors into account:
  - The applicant's requested grant amount.
  - The applicant's score on the scoring rubric.
  - The total amount of funding available for awarding.



## Grant Term (expected)

- 24 months from July 1, 2025 June 30, 2027
- Awardees may have up to two years to expend a grant. During a grant term, grant recipients are expected to fully expend grant funds while ensuring full transparency and accountability for all expenditures.
- Any unspent amount of the grant at the end of the two-year period of encumbrance shall revert to the Chancellor's Office.



#### Reporting Requirements

- Bi-annual reports in NOVA are required
- An end-of-project final report is due in NOVA

## **Reporting Expectations**



The number of additional nursing education program enrollment slots created with the use of grants.

As a condition of receiving a grant, a recipient shall report in January the following:



Student outcomes, including course success rates, persistence rates, graduation rates, NCLEX first time pass rate, and, if possible, employment placement outcomes.



How the grant was used by expenditure category, as described in the Purpose section (page 3).





The extent to which the grant, combined with other funding sources, addressed regional workforce needs.

## Additional Required Program Metrics

- 1) Number of students transferring to four-year BSN programs
- 2) Number of BSN transfer pathways
- 3) Number of students earning ADNs
- 4) Number of students enrolled
- 5) Demographics of enrolled students to include age, race, gender and language spoken at home
- 6) Number of students completing
- 7) Demographics of completers to include age, race, gender and language spoken at home
- 8) Program expenditures

Due Date: **Jan. 31, 2025, by 11:59 PM** 

Must submit Application in NOVA

Applications are screened and Evaluated

#### Screening Criteria

- 1. The application was submitted by a California community college district.
- 2. The application was received by the submission deadline (no drafts will be accepted).
- 3. The application was submitted in the required format with all required information.
- 4. The application included all sections, including a budget and budget justification.

## **Application Evaluation**

Applications will be evaluated based on criteria and quality and sufficiency of addressing the RFA's purpose

- Scoring will be conducted using a 110-point scale
- Applications must receive at least a score of 75 to be eligible for award
  - Receipt of minimum score does not guarantee funding

20 points possible

#### California Community Colleges

#### Identification of Need

- Provide a statement identifying the specific needs or problems the applicant faces regarding access to educating, supporting, graduating, or placing nursing students.
- Must demonstrate how the needs connect to one or a combination of the purposes listed in the "Purpose" section

#### **Current Approach**

- How the applicant is currently addressing the needs or problems described in Identification of Need(s) (above)
- What existing funds are currently supporting these efforts?
- How will receipt of this grant supplement those efforts?

## Application Section Review (2 of 4)

#### **GRANT AMOUNT AND PROPOSED USE OF FUNDS**

## Amount Requested and Summary of Proposed Use (20 points)

#### This section should include:

- Grant amount requested (should not exceed \$2,000,000)
- Summary description of the proposed use of the grant to address one or a combination of the legislative purposes
- how the proposed use will enhance and expand associate degree in nursing programs to cultivate, educate, and sustain the next generation of registered nurses

#### Workplan (40 points)

Detailed plan of action for how the applicant:

- i. Will address the identified needs,
- ii. Implement strategies listed in the proposed use of the funds,
- iii. Achieve the specified purposes of the grant.

Applicant must include a detailed plan describing the project's annual tasks and activities, its timeline, the expected measurable outcomes and deliverables, and the individuals or positions who will be responsible. The work plan serves to show how work will be conducted to achieve what is described in the Summary of Proposed Use.

## Application Section Review (3 of 4)

#### BUDGET AMOUNT, SUMMARY AND DETAIL 20 points possible

#### **Budget by Object Code**

Provide a budget by object code with detailed descriptions.

NOVA allows for expenditure object code 1000-7000:

1000 – Instructional Salaries

2000 - Non-Instructional Salaries

3000 - Employee Benefits

4000 – Supplies and Materials

5000 – Other Operating Expenses and Services

6000 – Capital Outlay

7000 – Other Outgoing Indirect Costs

Indirect costs should not exceed 4 percent and should be calculated as follows:

Grant Amount ÷ 1.04 = Grant Operating Budget × 4 percent = Indirect Costs



#### Other funding sources

 include a breakdown of the amount and use of other funding sources that the applicant is using for nursing education programs

## Application Selection (4 of 4)

#### **PRIORITY CONSIDERATION**

Total possible points: up to 10

- Applicants located in an underserved nursing area or a region with a local nursing shortage.
  - Nursing shortage Map
- Applications that expand existing bachelor of science in nursing partnerships with a campus of the California State University or the University of California.

1 point possible each (can apply for 2 max)

- Applications that develop new programs resulting in students qualified to sit for the NCLEX exam
- Applications with strategies for recruiting and retaining faculty.
- Applications with plans to address clinical placement shortages
- Applications that revise and/or update curriculum to integrate best practices in Diversity, Equity, Inclusion and Accessibility (DEIA) strategies and expand the use of immersive technology.

## Incomplete and Late Applications

Incomplete or late applications will not be considered. The WEDD Selection Committees reserve the right to reject any and all applications received prior to scoring should the following occur:

- The application is not received through the NOVA system by 11:59PM on January 31, 2025. NOVA will not accept applications after the deadline. No other forms of submission will be accepted.
- Ensure all application revisions are submitted by the deadline above.
   Any draft applications will not be considered for award.



## Appeals Process Part 1 of 2

- Applicants who wish to appeal a grant award decision must submit a letter of appeal to the Chancellor's Office no later than 5:00PM on March 31, 2025; the letter of appeal must include the signature by the college president or designee.
  - Only emailed letters will be accepted.
  - Appeals should be submitted to Vice Chancellor Anthony Cordova at the following email address <u>ACordova@CCCCO.edu</u>
  - The final decision will be provided in writing within 30 calendar days from the date that appeals are due.
  - The Chancellor's Office decision shall be the final administrative action afforded the appeal.



#### Appeals Process Part 2 of 2

- The appeal must specify the grounds of appeal and must be based on the process and/or procedures used in the review and recommendation of applications for awards.
- The applicant must file a full and complete written appeal, including the process(s) in dispute.
- Incomplete or late appeals will not be considered.
- The applicant may not supply any new information that was not contained in the original application.
