California Community College ADN Registered Nursing Programs

76 Associates Degree of Nursing (ADN) Programs

896 Full Time Equivalent (FTE) Instructional Staff

4000-5000 ADN Degrees Awarded Annually

California's Nursing Demand

Statewide Annual Demand for RNs

• 24,000

Number Produced Annually

• 21,570

Annual Unmet Need

• 2,430



Need for Program Alignment

5 fastest-growing community college nursing programs*

- Grew by 140%
- Per student funding declined 58%.

5 fastest-<u>shrinking</u> community college nursing programs *

- 95% average decrease in size
- Per student funding increased nearly 1,800%.

The <u>overall</u> number of students has declined by 9-10%

• 5,600 in 2016 to 5,100 in 2022.



Realignment to Legislation (1 of 2)

Education Code section 78261 et. seq., (SB 139, Scott), enacted in 2007, provides funds authorized by the State of California for the California Community Colleges Nursing Enrollment Growth and Retention Program. In part, the intent of the legislation is to facilitate both the expansion of the ADN programs and to improve completion rates in those programs.

These Nursing Growth and Retention grants provide funds to local community college ADN/RN nursing programs to assist in the development of activities increasing the capacity of the nursing program to reduce attrition, increase enrollment and increase the number of students who graduate.



Realignment to Legislation (2 of 2)

Retention
Colleges repeatedly
exceeding a 15% attrition
guidelines.

19 Colleges in 22-23

Colleges in the Retention categories have exceeded the 15% BRN attrition target:

3x in the past 6 years and 1x in the past 2 years

Growth
Colleges with a trend of meeting at or below the 15% guidelines

56 Colleges in 22-23

Guardrails



Stability for our nursing programs is a priority as we implement these changes.



Colleges will not experience decrease funding by greater than 15% from its prior year's allocation

Exception if a college no longer has an ADN registered nursing Program

Uses of Funding - Retention

Education Code Section 78261 (d)(1)

- Supportive services include, but are not necessarily limited to, tutoring, case management, mentoring, and counseling services.
- Funds may also be used to develop alternative delivery models such as part-time, evening, weekend, and summer program offerings.



Uses of Funding - Growth

Education Code Sections 78261 (b) and (d)

- Expanding enrollment, providing diagnostic assessments, and offering pre-entry coursework to prospective nursing students.
- (Offering) diagnostic assessments and supportive services to enrolled nursing students.

How to Apply (1 out of 2)

- Applications are now open in NOVA!
- Preliminary applications will require:
 - LOI signed by authorized district/college signatories
 - (reference appendix B in the LOI for template)
 - Written responses to questions
 - Budget estimate

Due in NOVA by June 22, 2023, 5:00 PM.



How to Apply (2 out of 2)

- Once the applications have been entered into NOVA, the Chancellor's Office will make the final determination of award amounts based on the requests received.
- At that time, applicants will be asked to enter a workplan and revised budget in NOVA.
