Statewide Taskforce Objectives


Deliverables:

- 1. By May 2022, make preliminary recommendations to the Board of Governors on a broad mission statement for a comprehensive and effectively structured students housing program for California Community Colleges.
- 2. By November 2022, make recommendations to define a clear program structure for affordable student housing within the system; create minimum standards for affordable student housing across the system; and identify technical assistance and professional development supports for the successful local implementation of student housing programs.

Affordable Student Housing

- The 2022-23 May Revision does not present recommendations for additional affordable student housing grant funds.
- The Senate's Putting Wealth to Work plan seeks an additional investment of \$1.5 billion in affordable student housing.
- Chancellor's Office advocating for proposed and eligible projects



Affordable Student Housing Budget Advocacy

- Award Construction Grants for 2021-22. Support the allocation of 2021-22 Higher Education Student Housing Grants to the four proposed projects.
- Award Construction Grants to All Eligible Projects with a New Investment. Provide a new ~\$350 million one-time non-Proposition 98 General Fund investment to fund affordable student housing construction grants for all eligible projects.
- **Provide Planning Grants to All Eligible Projects.** Support the approach that provides all 75 planning grant applicants with resources to begin the critical work of analyzing the feasibility and development of affordable student housing projects in their communities.

Draft Mission Statement

For California Community Colleges, the Affordable Student Housing agenda is grounded on principles of student equity, affordability, student-centered design, holistic supports, and district adaptability to student needs. Guided by these principles, the mission of the Affordable Student Housing program is to advance:

- Equity. Examine disproportionate impacts and design to meet the needs and long-term success of students most adversely affected.
- Affordability. Commit to housing that advances college access and affordability for students with greatest economic need.



Draft Mission Statement, cont'd

- Address Housing Shortages. Community colleges are an important partner and can play a key role in reducing statewide and community housing shortages that hinder our social and economic progress.
- Fiscal Sustainability. Plan for and support the long-term quality and viability of affordable student housing at colleges and communities where a need exists and can be supported.
- Student-Success Design. Recognize that affordable student housing cannot exist in isolation from holistic supports and interventions such as basic needs, financial aid, transportation, social services, campus culture, and learning supports for success.

Vision Goals

- 1. Increase credential obtainment by 20%
- 2. Increase transfer by 35% to UC and CSU
- Decrease average unit obtainment for a degree to 79
- Increase employment for CE students to 76% in their field of study
- 5. Reduce and erase equity gaps
- 6. Reduce regional gaps

Commitments

- 1. Focus on students' goals
- Design with the students' experience in mind
- Pair high expectations with high support






Student-Centered Support Ecosystem






Framework in Action I: Clarifying Problems






Housing Challenges in the CCCs

- Actively pursue structural changes that shift or remove student burdens
- Understand constraints in state and/or federal requirements and system misalignments
- Identify common workarounds to inform advocacy
