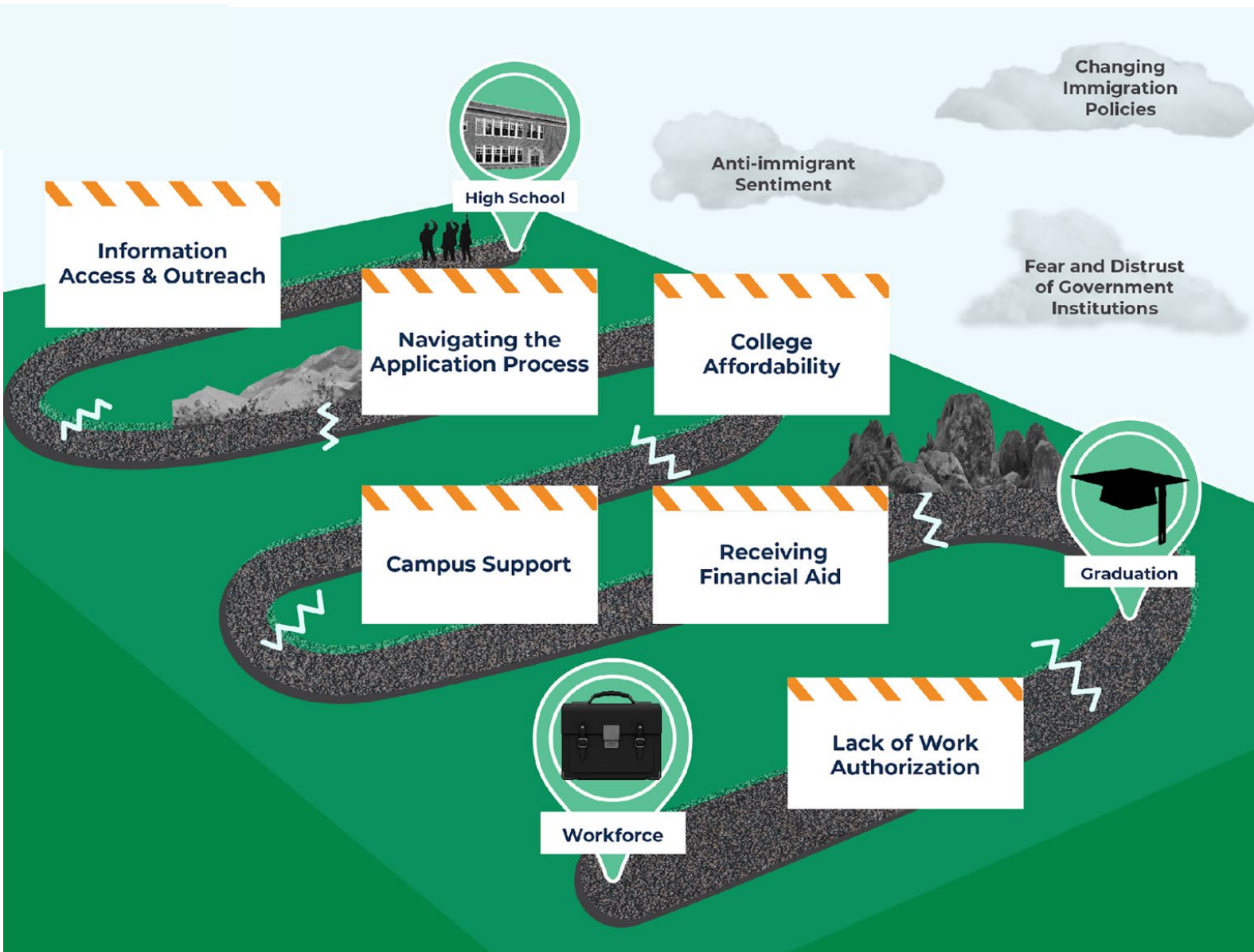

# CALIFORNIA DREAM ACT APPLICATION (CADAA)

CA's financial aid application (administered by CSAC) to determine *state* and *institutional* financial aid eligibility for students who cannot submit a FAFSA

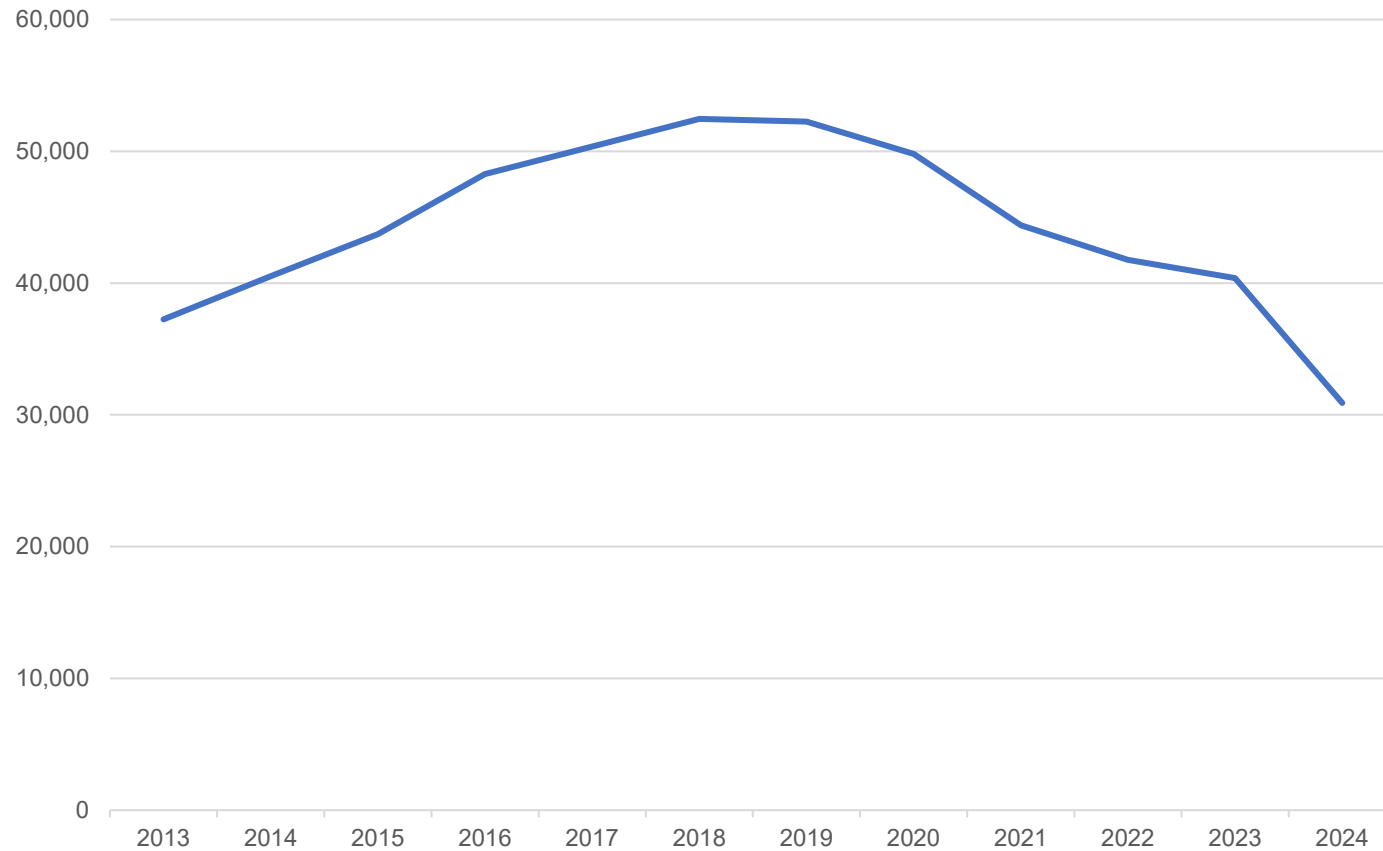

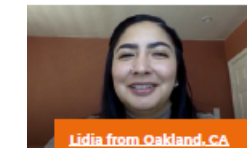

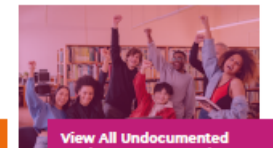

# 2025-26 CA Dream Act Application

## Key Updates

- 2025-26 CADAA will open on **December 1, 2024**
  - Ensures a stable CADAA release that aligns with FAFSA technical changes
- CADAA will continue to be an option for students from **mixed-status families**
  - Federal Student Aid continues to work out account creation issues for non-SSN contributors



# Facilitating a Smoother AB 540 Process

## AB 1540 (2023)

- Embedded the AB 540 Affidavit into the CADAA starting in 24/25
- Public institutions must accept students' AB 540 affidavit provided via the CADAA  
Institutions can provide their own affidavit for students who do not submit a CADAA
- "AB 540 School Report" captures AB 540 Affidavit responses
  - Housed within Web Grants > CADAA > AB 540 School Report
  - Web Grants System Administrators (SA) at each campus can grant access
  - SAs typically work in the financial aid office
  - CSAC School Support 1-800-294-0153 for help identifying your school's SA

# Reducing Burden of Proof in the AB 540 Process

## REMINDER #1:

- Institutions (*not CSAC*) will continue to be the only entity responsible for determining students' AB 540 eligibility

## REMINDER #2:

- Per recent updates to the CCCCCO's regulations on Nonresident Tuition Exemption Implementation, community colleges are permitted to accept AB 540 affidavits submitted via CADAA, and practice self-certification

## REMINDER #3:

- CSAC's Program Compliance auditors will continue to follow colleges' existing AB 540 policies and procedures (including self-certification policies)  
[Grant Special Alert 2024-40 \(ca.gov\)](#)

- No need to ask students for additional documentation beyond existing policies
- No need to store documentation beyond existing policies

# Forthcoming Enhancements to the CA Dream Act Application

- Inclusion of “credits/hours” on AB 540 section of CADAA
  - Help text will provide calculation instructions
- California Department of Education and CSAC data sharing agreement
  - CSAC will receive 9-12<sup>th</sup> grade enrollment data for public school students
  - Reduce burden of proof for students’, especially if attending a self-certification campus
  - Staff at non-self-certification campuses save time and focus on helping students with more complicated pathways to AB 540
- Inclusion of IRS tax form screenshots within help text

# Dream Act Service Incentive Grant (DSIG)

# Objective:

To inform and engage college staff and faculty on the effective implementation of the Dream Act Service Incentive Grant (DSIG), while highlighting the importance of interdepartmental collaboration to ensure eligible undocumented students receive financial support through community service, and to foster a coordinated approach for tracking, promoting, and administering the grant.



# Overview of the Dream Act Service Incentive Grant (DSIG)

## What is DSIG?

- The California Dream Act Service Incentive Grant (DSIG) Program offers up to \$4,500 per year to eligible Dream Act students with Cal Grant A or B awards. Students can receive funding for up to 8 semesters or 12 quarters while completing community service. To remain eligible, students must meet Satisfactory Academic Progress and complete any required Cal Grant verification.

## Eligibility

- Completed and submitted California Dream Act Application (CADAA).
- Is an active recipient of a Cal Grant A or Cal Grant B award. Cal Grant A recipients must have met Cal Grant B eligibility.
- Demonstrate enough financial need (determined by CSAC or the institution).
- Enrolled in a qualifying institutions.

# Importance and Benefits of DSIIG

- Financial Support for undocumented students without DACA
- Encourages community and civic engagement
- Enhances educational and career opportunities
- Promotes social responsibility and community involvement
- Cost free to our campus partners

# Implementing DSIG at SCC

- Work with Admissions and Records to run a query to determine potential applicants
- Received a query from Admissions & Records of all potential AB540 students and CADAA submissions and notified students about DSIG and the steps necessary to be considered for DSIG
- Work with Financial Aid Office to run a query on all applicants who submitted a CA Dream Act Application
- Inform departments about DSIG and its purpose while creating a list of host departments

# Collaborative Strategies

- Set-up one-on-ones with all coordinators/supervisor to inform them about DSIG and its purpose
- Walked campus partners through the DSIG application process
- Provide campus partners with an overview of how students track their hours
- Ensure coordinators/supervisors understand that DSIG students are no student workers, but volunteers

# DSIG Application Process @ SCC

1. Students interested in DSIG contact the First Year Support Center (FYSC) or are referred for assistance with the application.
2. Students are screened to ensure eligibility (i.e., CADAA submitted, Cal Grant Recipient, and SCC home location).
3. If eligible, the FYSC will assist the student by placing them in an office that best fits their interest.
4. The student is walked over to the Financial Aid Office so the Financial Aid Coordinator can complete Section 2.
5. After the Financial Aid Office completes Section 2, we walk the student over to the office they will be placed to complete Section 3 and ensure a warm hand-off.
6. Lastly, students eligible for DSIG must complete a Volunteer Service Form and Waiver Agreement. Students must complete a TB testing and livescan; however, we reimburse them through undocu-liaison funds.

# Outcomes and Impact

- Number of students who have applied (2024-2025): 15
- Number of students who are working on their hours: 10
- Number of students who applied and were approved but did not follow up: 1
- Number of students who did not qualify for DSIG: 4
- Number of student who did not qualify but SCC provided funds: 2
- Total of service hours estimate for Fall 2024: 1,800
- The overall impact on student success and community engagement:
  - Increase involvement and retention
  - Increase the opportunity to become competitive applicants for transfer and internships/fellowships
  - Increase student engagement
  - Increase financial opportunities
  - Create professional relationships with staff/faculty (networking)
  - Create a home away from home
