RE: 2021–22 Dual Enrollment Report

Education Code sections 76002 and 76004 require the California Community Colleges Chancellor's Office to prepare and submit a report each year on 1) the number of special part-time and special full-time equivalent students (FTES) claimed by each community college district for the preceding academic year and 2) College and Career Access Pathways (CCAP) data. These sections require the following report data:

Education Code Section 76002 – Special part-time and special full-time equivalent FTES claimed for:

- A. Noncredit (Table 1).
- B. Nondegree-applicable (Table 1).
- C. Degree-applicable, excluding physical education (Table 1).
- D. Degree-applicable physical education (Table 1).

In addition to the above, the statute requests the number of systemwide summer session students with passing grades for multiple fiscal years and by year-to-year percentage change (Table 3), as required by Education Code section 48800.

Education Code Section 76004 – CCAP partnership data for:

- A. Total number of high school pupils by school site enrolled in CCAP, aggregated by gender and ethnicity (Tables 7 & 8).
- B. Total number of community college courses by course category and type and by school site (Table 9).
- C. Total number and percentage of successful course completions, by course category and type and by school site (Table 9).
- D. Total number of full-time FTES generated by CCAP partnerships (Table 4).
- E. Total number of students served online from CCAP partnerships (Table 10).

Community colleges serve special part-time and special full-time students through multiple dual enrollment programs. Programs are offered primarily through College and Career Access pathways partnerships (CCAP), Non-College and Career Access pathways partnerships (Non-CCAP), and Early-and Middle-college high school programs.

The information obtained from the Chancellor's Office Management Information Systems (MIS) for CCAP partnerships is by district and college. MIS does not require districts or colleges to report high school site data; therefore, the CCAP data provided in this report includes district and/or college but does not identify participants high school site.

The FTES data included in the tables is consistent with the data reported in the Chancellor's Office Data Mart. However, Data Mart FTES varies from the FTES reported for funding purposes due primarily to differences in timing of submissions between the two reports.
