#### **INTRODUCTION**

The Disabled Student Programs and Services (DSPS) assists students with disabilities so they have equal access to all educational programs and activities on campus. DSPS provides support services to students with physical disabilities, learning disabilities, psychological disabilities, developmental delay, brain injury, visual impairments, health problems and hearing impairments. Among the array of services offered are priority registration, specialized counseling, class scheduling, mobility assistance, test proctoring, specialized tutoring, transcription services, and interpreter services for hearing impaired or deaf students.

This report includes a statewide review of 2019-2020 and 2020-2021 enrollment, retention, transition, and graduation rates of all community college students receiving services through DSPS.

Each California community college used state funding allocated for DSPS to provide support services and educational accommodations to 118,257 students during the 2019-20 and 93,877 students during the 2020-21 academic years with disabilities so they can have full and equitable access to community college classes. In addition, most colleges include specialized instruction as part of their DSPS program. Examples of services the colleges provide to students with disabilities include test proctoring, learning disability assessment, specialized counseling, interpreter or captioning services for hearing-impaired and/or deaf students, mobility assistance, note taker services, reader services, transcription services, specialized tutoring, access to adaptive equipment, job development/placement, registration assistance and special parking. academic year.

The data show that students with disabilities represent just under 7% of the population of the California community colleges. The key findings from the 2019-2020 and 2020-2021 academic years are as follows:

- DSPS student enrollment saw a decline at a rate similar to that of the overall student population.
- DSPS students lag behind students without a disability in credit class enrollment but exceed them in noncredit courses.
- Noncredit course attendance dropped 50% for DSPS in 2020-2021 compared to 2019-2020.
- DSPS students perform similarly in workforce preparation courses when compared to students without disabilities.

Basic skills course pass rate for DSPS student was 66% in 2019-20, with a modest gain to 69% in 2020-21.

#### STUDENT COUNTS

The student counts in the Table 1 represent the total enrollment of DSPS students across our 115 physical California community colleges. Between 2019-20 and 2020-21, the overall number of students decreased by 12%. The disabled student population decreased also, at roughly the same rate. While the number of DSPS students decreased, the drop in DSPS enrollment is consistent with the statewide enrollment declines for the same period.

The data presented on Table 2 breaks down the number of students served by DSPS by disability category. The categories exist in recognition of the variable costs of serving different disability types. In addition to Speech as noted, the "other" disability category is most commonly comprised of those with conditions related to chronic fatigue or pain. Some examples include but are not limited to cardiovascular disease, chronic obstructive pulmonary disease, asthma, cancer, HIV, hepatitis, lupus, Tourette syndrome, seizure disorders, chronic fatigue, multiple chemical sensitivity or severe allergies.



#### **DSPS STUDENT OUTCOME DATA**

#### **EDUCATIONAL ASSISTANCE COURSE ENROLLMENT**

Educational assistance classes are designed to address the educational limitations of students with disabilities who are admitted to the institution and who would be unable to substantially benefit from general college classes even with appropriate academic adjustments, auxiliary aides and services. The courses are designed to address the educational limitations of students with disabilities but are open to all students. DSPS students represented 36% of students enrolled in educational assistance courses in 2019-20. In 2020-21, DSPS students represented 41% of students enrolled in educational assistance courses. Overall educational assistance course enrollment dropped, but with a return to inperson instruction, it is expected that these numbers will rebound.


#### **Educational Assistance Enrollment Count**



#### **BASIC SKILLS COURSES RETENTION AND SUCCESS RATE**

Basic skills, more commonly known as remedial education, has undergone changes in an effort to eliminate achievement gaps among underprepared students. The chart below illustrates that for 2019-20, DSPS and non-DSPS students had very similar retention rates in basic skills courses. In 2020-21, DSPS rates increased while non-DSPS actually dropped two percentage points. Looking at success rates for 2019-20, DSPS lagged behind their non-disabled peers. In 2020-21, the reverse was seen, with DSPS outperforming by three percentage points.


#### **Basic Skill Courses Retention & Success Rate**



#### RETENTION AND PERSISTENCE

The persistence rate for non-DSPS students decreased more than for DSPS (45% vs 56%), but persistence for both populations fell short of previous years. The percentages for retention and persistence were obtained from the students enrolled in the fall of 2019 and divided by those students enrolled again in the fall of 2020. The data to compare fall 2020 to fall 2021 was not yet available at the time of reporting.

#### **DEGREE AND CERTIFICATE ATTAINMENT**

The results below represent continued improvement in this measurement. DSPS students outperformed non-DSPS students in degree attainment and credit certificates earned in both 2019-20 and 2020-21. This is evidence that with the right supports in place, students with disabilities can excel and even surpass the achievements of their non-disabled peers.


#### % Earned a Degree/Certificate/Award



#### TRANSFER READY

To be considered "transfer-ready," a student must be both transfer-directed (completed a transferable English and a transferable math course) and transfer-prepared (earned 60+ transferable units with a 2.00+ GPA). Again as a percentage, students with disabilities are reaching this important milestone at higher rates than their non-DSPS peers.

#### **Transfer Ready Status**




