EXECUTIVE SUMMARY

In March 2020, the Coronavirus Disease 19 (COVID-19) pandemic disproportionately disrupted the daily life of underrepresented students enrolled in California Community Colleges. Prior to COVID-19, these students faced racial and economic disparities statewide, but the pandemic forced a larger burden on an existing vulnerable population with its economic fallout.

Fortunately, in response to the COVID-19 pandemic and through the receipt of federal Coronavirus Aid, Relief, and Economic Security (CARES) Act stimulus relief, the Governor and California Legislature allocated one-time funds, known as the COVID-19 Response Block Grant (Block Grant), in the 2020 Budget Act to community college districts with the intent that districts prioritize services for underrepresented students. The Block Grant is comprised of \$66.255 million from Proposition (Prop) 98 funds.

Today, California's community colleges, the largest system of higher education in California, continues to serve 1.9 million students, which serves as the cornerstone to higher education for low income, Latinx and Black students.

This report details the uses of the \$66.255 million and describes how community colleges prioritized the funds to serve underrepresented students and the effectiveness of the services provided from inception of the awards through June 30, 2022.

California community colleges primarily used Proposition 98 funds to:

- Facilitate distance learning, in part by providing laptops and Wi-Fi hotspots to economically disadvantaged students;
- Improve teleworking capabilities of community college employees and instructors to ensure continuance of education;
- Cover payroll for public health and safety employees and other essential staff diverted to developing online capabilities and responding to the pandemic; and
- COVID-19 Testing and Contact Tracing to mitigate the spread of COVID-19

As a result, community colleges were able to provide current and incoming students distance education learning opportunities through the 2021-22 academic year and beyond. In addition, students received emergency grants, laptops, Wi-Fi hot spots, meals, and housing assistance. During this difficult time, student success metrics for the 2021-22 academic year, shows year over year gains in the number of associate degrees for transfer, transfers to four year colleges and attainment of a regional living wage.¹ However, completion of transfer level Math and English declined by 1%.

As a higher educational system, the California Community Colleges proudly put students first by innovating learning modalities offered and providing funding and tools to meet student needs. These swift and student-focused initiatives guaranteed that students facing difficulties received the necessary assistance while adapting to the novel challenges posed by the pandemic, thus allowing them to persist in their educational goals.

BACKGROUND

CALIFORNIA COMMUNITY COLLEGES

The California Community Colleges is the largest system of higher education in the country with more than 1.9 million students enrolled at 116 colleges. The student population closely reflects the diverse demographics of California: 45% of our students are Latinx, 27% white, 10% Asian, 9% multi-ethnic or unknown, 6% Black, 2% Filipino and 1% Native American or Pacific Islander.² Along with this diversified population come unique challenges, as underrepresented students frequently face increased systemic poverty and historical equity gaps in completion rates.

COVID-19 PANDEMIC DISPROPORTIONATELY AFFECTS UNDERREPRESENTED POPULATIONS

The economic challenges inflicted by the COVID-19 pandemic have affected millions of Americans, hitting the most vulnerable communities the hardest. Among those significantly affected are community college students, who grapple with the task of completing their educational aspirations and professional objectives amidst financial constraints and familial duties. A considerable number of these students lack the means to access the technology and resources necessary for effective participation in remote learning.

2020 COVID-19 RESPONSE BLOCK GRANT

BLOCK GRANT ALLOCATION

The California Legislature, through the 2020 Budget Act, provided California Community Colleges with state relief of \$66.255 million from state Proposition 98 funds.

The Block Grant allocation was based on district pro-rata share of total 2018-19 Full-Time Equivalent Students (FTES). For a complete schedule of Block Grant allocations to districts, see Appendix A: COVID-19 Response Block Grant Allocation by District.

Additionally, multi-college districts used local discretion to allocate funds both to individual colleges and for district-wide purposes. For a summary of Prop 98 funds provided to individual colleges, see Appendix B: COVID-19 Response Block Grant Allocation by College.

BLOCK GRANT ALLOWABLE EXPENDITURES

The Legislature intended Block Grant funds to be used to prioritize services for underrepresented students and directly support student learning, continuity of education, and mitigate learning loss related to the COVID-19 pandemic. In addition, payments from these funds must meet the following federal CARES Act expense requirements:

- Necessary and incurred due to the public health emergency with respect to the COVID–19 beginning March 1, 2020
- Not accounted for in the budget most recently approved as of March 27, 2020 (the date of enactment of the CARES Act) for the State or government; and

• Incurred during the period that begins on March 1, 2020, and ends on June 30, 2022.³

The U.S. Treasury Department provided further guidance and expenditure categories. For a detailed description of allowable expenditure categories, see Appendix C: COVID-19 Response Block Grant Description of Block Grant Allowable Expenditures. Allowable expense categories include, but not limited to:

- Administrative Expenses
- Budgeted Personnel and Services Diverted to a Substantially Different Use

- Medical Expenses
- Payroll for Public Health and Safety Employees
- Personal Protective Equipment (PPE)
- Public Health Expenses
- Other Allowable Expenses

COVID-19 RESPONSE BLOCK GRANT STATE PROPOSITION 98 EXPENDITURES AND ENCUMBRANCES

As of August 2023, the California Community Colleges expended \$66.025 million and have an unspent amount of approximately \$229,912.

California community colleges primarily used Coronavirus Relief Funds to facilitate distance learning, in part by providing laptops and Wi-Fi hotspots to economically disadvantaged students, improve teleworking capabilities of community college employees and instructors, and cover payroll for public health and safety employees and other staff diverted to developing online capabilities and responding to the pandemic.

As shown in Chart 1 below, 31% of Prop 98 funds were spent to facilitate distance learning; 13% to improve telework capabilities for employees; 9% for payroll of public health and



campus safety employees; 9% for COVID-19 Testing and Contact Tracing; 8% for personnel and services diverted to a substantially different use; 7% for public health expenses; 7% for economic support (other than Small Business, Housing, and Food assistance); 7% for Personal Protective Equipment (PPE); 3% for food programs; 5% for other expenses (housing support, unemployment benefits, expenses associated with the issuance of tax revenue anticipation notes (TRANs), medical expenses); 1% for administrative expenses. EXPENDITURES TO FACILITATE DISTANCE LEARNING

Prior to the COVID-19 pandemic, most community college courses were delivered via face to-face instruction. The greatest challenge for colleges has been to convert all face to-face instruction to a distance education mode of instruction and provide students and faculty with the tools and support necessary to thrive in an online environment. To meet this challenge, districts invested \$20.3 million to facilitate distance learning. Investments to close the digital divide and other activities to facilitate distance learning for students totaled 93% of expenditures in this category and include providing laptops and equipment, Wi-Fi hotspots and remote tutoring to students. Expenditures to support faculty professional development and grants total 7%. Chart 2 below illustrates how Prop 98 facilitated distance learning.



PRIORITIZATION OF SERVICES FOR UNDERREPRESENTED STUDENTS

With approximately 73% of enrolled students representing underserved populations, California community colleges were poised to prioritize services for underrepresented students, who often have more environmental and financial challenges when attempting distance education courses and have fewer resources on which to rely for assistance. To prioritize support, most districts awarded financial awards and equipment based on demonstrated financial need such as Pell Grant or California College Promise Grant eligibility.

EFFECTIVENESS OF SERVICES FUNDED BY THE BLOCK GRANT

Block Grant funds have had a significant positive impact on students' ability to continue their education during the pandemic.

Preliminary data for the 2021-22 academic year indicates improvements in several student success metrics under the Student Centered Funding Formula, despite pandemic challenges. Awards of associate degrees for transfer increased by 1.4% from the prior year, transfers to four-year institutions increased by 1%, attainment of a regional living wage increased by 5% and completion of transfer level Math and English decreased by 1%.⁴

Incorporating emergency grants into the financial aid distribution timeline provided students displaying need with prompt access to funds, aiding them during this period. Initiatives enabling access to laptops and internet connectivity enabled underrepresented students to sustain their enrollment and pursue their studies. Furthermore, colleges expedited the transition of classes to online platforms to mitigate learning disruptions, while faculty adeptly navigated online instruction to uphold educational excellence. The availability of the COVID-19 Response Block Grant funds made all these essential services feasible.

CONCLUSION

While the world continues to grapple with the repercussions of the COVID-19 pandemic, the glaring disparities resulting from the economic downturn have become increasingly evident. In California, there exists a paradox where the ongoing economic rebound worsens inequalities for the most vulnerable residents while further enriching the affluent. The California Community Colleges have emerged as a crucial force in the state's battle against COVID-19. Serving as the foremost provider of workforce training and boasting the most extensive higher education system in the region, the California Community Colleges stand as a primary avenue for the state's resurgence and an opportunity for comprehensive economic advancement. These institutions play a pivotal role in preparing indispensable first responders, nurses, police officers, firefighters, and construction workers who are essential to the pandemic response and recovery efforts.

Even though the state of emergency has concluded, the pandemic's impact persists in campus operations and students' daily lives. California community colleges are actively

addressing ongoing student needs for mental health services, housing, and food security. As these colleges implement safety measures to curb the spread of COVID-19 and uphold their commitment to safe and open campuses with in-person instruction, we earnestly appeal to the Governor and Legislators for additional state resources. These resources are vital to support colleges' strategies for reengagement, which include adaptive hybrid models and the facilitation of more flexible academic schedules, such as late-start classes and programs tailored for working learners. It's evident that the crisis is ongoing, and much more remains to be accomplished. California's 116 community colleges are poised to continue spearheading innovative initiatives to aid Californians in navigating the new economic challenges stemming from the COVID-19 public health crisis.
