Dear Secretary Contreras,

Pursuant to California Education Code sections 78261(h)(2) and 78261.5, the California Community Colleges Chancellor's Office (Chancellor's Office) and the Board of Governors for California Community Colleges are releasing this combined report on California community colleges nursing education programs and the multicriteria selection process for 2023-24.

The Chancellor's Office recently established a Memorandum of Understanding with Assessment Technologies Institute, LLC to manage collection of the data necessary in order to fulfill the reporting requirements outlined in this statute. A comprehensive, updated version of the report is anticipated in the summer of 2026. In the interim, this initial version of the report includes the information currently available for 2023-24: the number of students who completed community college nursing programs; the percentage of those who completed the program by age, ethnicity, and gender; and a list of the colleges who did and did not participate in a multicriteria selection process.

EXECUTIVE SUMMARY

With this report, the California Community Colleges Chancellor's Office (Chancellor's Office) responds to the reporting requirements outlined in Education Code sections 78261(h)(2) and 78261.5, providing the information currently available for 2023–24. During that year, 77 California Community College (CCC) associate degree nursing (ADN) programs received a total of approximately \$13 million in nursing support grants.

At the time of this report's preparation, the data collection process for the periods of 2023-2024 and 2024-25 is still in progress. The Chancellor's Office recently established a Memorandum of Understanding with Assessment Technologies Institute, LLC (ATI) to collect the majority of the data needed to fulfill the requirements outlined in the statutes referenced above. Therefore, this initial report will contain only the information currently available, including: 1) the number of students who completed an Associate Degree in Nursing (ADN) program in the 2023-24 period; 2) lists of colleges that participated and did not participate in a multicriteria screening process during this same period; and 3) of those students who completed an ADN program, the percentage of students by age, gender, and ethnicity groupings.

The next version of this report, anticipated in summer 2026, will contain complete data that reflects how the grant-funded nursing programs impacted student assessment, enrollment, retention, completion, and licensure in both the 2023-24 and 2024-25 fiscal years.

INTRODUCTION

California community college nursing programs are essential to addressing the nursing shortage and provide a source of high-wage, high-demand occupations for students. California provides the highest employment level of registered nurses in the United States and is the top paying state in the country with an hourly mean wage of \$71.31 and an annual mean wage of \$148,330 (Bureau of Labor Statistics, 2024). Thus, registered nursing is a path that promotes upward mobility and family-sustaining wages for California community college students.

The California Nurse Education Initiative, established in 2005, was designed to make progress in addressing the state's nursing shortage. The supply of nurses relies heavily on the state's higher education system, including California community college nursing programs, which train and supply a large proportion of the nurses in California. California community college ADN programs currently account for 55.4% of the total nursing schools in the state (77 of 139 nursing schools), graduate about half of the state's nurses, and satisfy about 20% of the state's demand for nurses (2023-24 California Board of Registered Nursing Dashboard and California Community Colleges Chancellor's Office Economic and Workforce Development Centers of Excellence for Labor Market Research, COECCC).

The California Community Colleges system serves approximately 2.2 million students each year and is the largest and most diverse system of public higher education in the nation. The state's 116 community colleges have multiple missions, including: to create strategies to bring college to low-income workers; to develop systems supporting flexible course-taking opportunities; and to build infrastructure for credit for prior learning.

This report responds to the requirements of the Chancellor's Office outlined in Education Code Sections 78261(h)(2) and 78261.5.

ED CODE 78261

California Education Code section 78261 mandates that the Chancellor's Office provides specific data pertaining to nursing programs. In 2023-24, 77 colleges received grants for enrollment growth and retention purposes.

Typically, this report would include data related to all reporting requirements as well as supplemental data. However, for this initial 2023-24 report, the data collection process is still in progress. The limited information currently available is indicated below, and the full report for 2023-24 and 2024-25 will be provided in summer of 2026.

Assessment

- The number of students taking diagnostic assessments (reporting requirement; not currently available)
- The number of students failing to meet proficiency levels as determined by diagnostic assessment tools (reporting requirement; not currently available)

Enrollment

- The number of students enrolled in the nursing program (reporting requirement; not currently available)

Retention & Completion

- The retention rates of colleges receiving Nursing Enrollment Growth & Retention Program grants (supplemental data; not currently available)
- The number of students who completed the associate degree nursing program (reporting requirement; available and included)

Licensure

- The number of students who pass the National Council Licensure Examination (NCLEX) (reporting requirement; not currently available)

ED CODE 78261.5

California Education Code Section 78261.5 outlines the admission procedures for community college registered nursing programs when the number of applicants exceeds available capacity. Institutions may admit students through a multicriteria screening (MCS) process, a random selection process, or a combination of both. This statute requires the Chancellor's Office to collect and maintain data on nursing program admissions policies and mandates the collection of demographic information for students admitted to and graduating from nursing programs.

Participation

- The number of students enrolled in the nursing program using a MCS admission process (reporting requirement; not currently available)
- Retention & Completion

- Information on the annual impact, if any, the Seymour-Campbell Student Success Act of 2012 had on the matriculation services for students admitted through the multicriteria screening process, as described in this section (reporting requirement; not currently available)

METHODOLOGY

The Chancellor's Office Workforce and Economic Development Division staff and the Research and Data Accountability Unit staff of the Digital Innovation and Infrastructure Division collected the data shared in this report. The sources include:

- Nursing Final Report Expenditures Survey
- Nursing Program Annual Data Submission
- California Board of Registered Nursing
- COECCC

DATA COLLECTION PROCESS

As previously mentioned, the Chancellor's Office has an established Memorandum of Understanding with Assessment Technologies Institute, LLC (ATI), and the data collection process for the nursing program is currently underway. In the forthcoming (summer 2026) 2023-2024 and 2024-25 report, the following information will be provided, and the information currently available for inclusion in this initial report is indicated.

Ed Code 78261:

- The number of students enrolled in the nursing program
- The number of students taking diagnostic assessments

- The number of students failing to meet proficiency levels as determined by diagnostic assessment tools
- The number of students failing to meet proficiency levels that undertake pre-entry preparation classes
- The number of students who successfully complete pre-entry preparation coursework
- The average number of months between initial diagnostic assessment, demonstration of readiness, and enrollment in the nursing program for students failing to meet proficiency standards on the initial diagnostic assessment
- The average number of months between diagnostic assessment and program enrollment for students meeting proficiency standards on the initial diagnostic assessment
- The number of students who completed the associate degree nursing program (included)
- The number of students who pass the National Council Licensure Examination (NCLEX)
- Data disaggregated by age, gender, ethnicity, and language spoken at home
- Ed Code 78261.5:
- The colleges that participated in a multi-criteria selection process (included)
- Enrollment, retention, and completion rate in community college registered nursing programs of students admitted through a multicriteria screening process disaggregated by age, ethnicity, gender, and language spoken by students at home (while the completion rate as a percentage of students enrolled is not yet available at the time of the writing of this report, information related to the age, ethnicity, and gender of those students who completed their program in the 2023-2024 academic year is available and provided herein)
- Annual impact of the Seymour-Campbell Student Success Act of 2012 on matriculation services for students admitted through the multicriteria screening process

KEY FINDINGS

ED CODE 78261

Assessment, Enrollment, and Retention

With the data collection process for 2023-24 and 2024-25 currently in progress, the assessment, enrollment, and retention data typically provided in this report is not yet available for the 2023-24 report. The data collection process that is underway in partnership with ATI will serve both to validate the data submitted directly to the Chancellor's Office by

the colleges and to enable full report completion. In the summer of 2026, the Chancellor's Office will provide complete 2023-24 information along with the complete 2024-25 report.

Completion

In 2023-24, a total of 4,848 students completed the associate degree in nursing program across the 76 colleges offering nursing programs. However, the completion rate (i.e., the percentage of enrolled students who successfully finished) cannot yet be calculated because the corresponding enrollment data are not yet available. This rate will be added in the updated version of the report scheduled for release next summer.

Tables 1-3 below show the distribution of students who completed ADN programs in 2023–24, broken down by age, ethnicity, and gender.

Once we have the anticipated data sets from ATI's currently active data collection process, the summer 2026 update will report on the progress made from July 1, 2023, through June 30, 2025.
