BACKGROUND

The Community Colleges Pathway to Law School (Cal LAW) initiative launched in 2014 with a goal of enhancing opportunities and advancement in the legal profession for diverse populations, particularly those who have traditionally been underrepresented. More than 700 community college students are currently enrolled in the program statewide, with more than 250 graduated Cal LAW Scholars already.

The initiative seeks to invest in the State's economic growth and global competitiveness through career education for the legal profession. At the core of the initiative is expanding diversity, equity, and inclusion by ensuring all students, regardless of race, age, economic status, or geography, gain exposure and confidence to pursue a Law career pathway. This initiative is intended to provide community college students, particularly women and people of color, with a direct path to law school, and to give those schools a pipeline of diverse students from across the state. Training students with 21st century skills is how

the California Community Colleges will contribute to breaking the cycle of poverty and give community college students, their families, and their communities the opportunity for true economic mobility.

The intent is to expand the Cal LAW pathways program at community colleges. This funding will provide colleges the opportunity to work together with Cal Law program partners to:

- Support opportunities for dual enrollment partnerships between community colleges and local high school law academies.
- Implement partnerships with California State Universities that incorporate associate degree for transfer pathways in preparing students for a career in the legal profession.
- Expand existing transfer agreements with the University of California that will prepare students for a career in the legal profession.
- Provide student advising and guidance to help participants in the Community College Pathway to Law School initiative successfully transfer into the California State University (CSU) or the University of California (UC).

The Cal LAW initiative requires students to complete courses that develop effective lawyers. Students in the program receive early exposure to the law school experience, individual advisement and mentoring from law school advisors, financial aid counseling, LSAT preparation, and waived application fees for admission to the participating law schools.

Letter of Intent Overview

The purpose of the Letter of Intent is to solicit and identify additional community college districts wishing to participate in the Cal LAW Program. Based on the Letters of Intent submitted to the Chancellor's Office, grant funding will be issued to colleges <u>not awarded in the first release of the Cal LAW LOI</u>, for up to a maximum of \$99,000 per college.

The grant funds are for selected districts to support costs associated with the Cal LAW Program, including:

- Faculty time to engage in:
 - o Providing student support in pathway advising;
 - Collaborating with K-12 and UC/CSU colleagues to create seamless pathways for students;
 - Attend meetings for planning and design of an initial or expanded offering to be delivered, as well as office hours with experts in the pathway planning and design process.
- Offset the cost of partners engaged in this work, including K-12 partners focused on designing dual enrollment opportunities, faculty time, costs of textbooks, and meeting time.

Eligibility

- Eligibility for this funding opportunity is limited to California
 Community College districts that did not receive funding in the first Cal
 LAW LOI.
- Districts must have an active State approved Associate Degree for Transfer (ADT) in Law, Public Policy and Society.
- Districts should have willingness to become part of the <u>California Law</u>
 <u>Pathways Program</u> administered by the Foundation for California
 Community Colleges.
- Districts should offer dual enrollment courses in at least two (2) of the seven (7) ADT in Law, Public Policy and Society pattern.
- Districts should have the operational capacity to implement, manage and achieve the performance objectives of the grant.

Grant Duration

The grant duration is for 18 months, and is expected to begin July 1, 2023 through December 31, 2024.

Summary Grant Activities

The following is an outline of the project deliverables. Grant funds will be paid upon the completion of each deliverable, via a submitted invoice regardless of actual expenditures incurred.

1. Finalize the Project Team and Supporting Cast

- Confirm two grant sponsors or champions (Chief Instructional Officer and Dean or equivalent administrators) at the college to support the project. These sponsors are identified in the Letter of Intent application.
- Confirm a five-member team to participate in the implementation of this program. It is recommended that the faculty team consists of faculty representing each of the following areas: Counseling, Articulation Officer, and discipline faculty (Lead faculty in the Law pathway) or faculty division chair where the pathway is housed, as well as the dual enrollment coordinator and the outreach team representative. These roles are identified in the Letter of Intent application.
- Inform and confirm additional relevant parties at the college referred to as "supporting cast" to maximize success and further enrich the pathway (.e., Communications or Public Relations, Counselors, Guided Pathways coordinator, Associated Student President, K-12 pathway coordinator, K-12 advisors, etc.).
- 2. Attend and participate in project meetings and convenings (estimated to be up to 3 hours per week for faculty over the grant period) working with program partners, in designing program delivery and continuous improvement. Participate in meetings with high school partners to design AB 288 (Chapter 618, Statutes of 2015) agreements related to Cal LAW Pathway and the active college Associate Degree for Transfer (ADT) in Law, Public Policy and Society. Participate in meeting with articulation officers and CSU/UC partners related to establishing and maintaining pathways for the ADT in Law, Public Policy and Society.
- 3. Plan, design, and deliver ADT courses related to the Law, Public Policy and Society ADT pathway to dual enrolled and community college students.
- 4. Provide evidence of similar degree pathways with Law, Public Policy and Society ADT with CSU/ UC partners.
- 5. Submit three reports (one every 6 months) and one final report to the Chancellor's Office upon completion of grant deliverables.

APPENDIX A – Glossary of Terms

AB 288	This bill authorized the governing board of a community college		
(Statutes	district to enter into a College and Career Access Pathways		
of 2015)	partnership with the governing board of a school district with the goal of developing seamless pathways from high school to community college for career technical education or preparation for transfer, improving high school graduation rates, or helping high school pupils achieve college and career readiness. The bill required the partnership agreement to outline the terms of the partnership, as specified, and to establish protocols for information sharing, joint facilities use, and parental consent for high school pupils to enroll in community college courses.		
	The bill authorized specified high school pupils to enroll in up to 15 units per term if those units are required for these pupils' partnership programs and specified conditions are satisfied, and would authorize a community college district to exempt special part-time and full-time students taking up to a maximum of 15 units per term from specified fee requirements. The bill prohibits a district from receiving a state allowance or apportionment for an instructional activity for which the partnering district has been, or will be, paid an allowance or apportionment under a concurrent enrollment partnership agreement.		
	The bill requires, for each partnership agreement entered into under the bill, the affected community college district and school district to provide an annual report, containing specified data, to the office of the Chancellor of the California Community Colleges. The bill required the Chancellor to prepare a summary report, no later than January 1, 2021, that includes an evaluation of the partnerships, as specified.

Dual	Dual enrollment – also known as concurrent enrollment – enables
Enrollment	high school students to take college courses, taught by college professors, at their high school campus. These courses can also count toward your high school diploma, allowing students to get a head start on their higher education goals.
