The CALIFORNIA NONRESIDENT TUITION EXEMPTION FORM or AB 540 Affidavit does not have to require an address. That would be a local decision at the college. A residency verification form would likely include an address section but if a student was housing insecure they should meet with their financial aid office to explore their situation and may be even be eligble for additional aid.

At Southern Illinois University, Carbondale, one of the greater barrieres is the financial aid for students that are US citizens with undocumented parents who do not file taxes. Some of those parents have been either deported or do not file taxes. However, these students are still considered dependent, have you encountered such issues, and have a specific process to help these students? Our FA office does not process the FAFSA form unless parents' taxes have been filed... There is a form 4506-T which has to be faxed to the IRS to request transcripts of Tax Return, but it does not apply to non filers. Any help of guidance will be greatly appreciated! Unfortunaely no. Even if a student has DACA they are not eligible for Federal work study, but some campuses have their own work study programs that students with DACA may qualify for...
