1. Overview of Strategic Vision Goals #5 and #6: Close equity gaps and close regional gaps – Sandy Fried, Executive Director, Student Success Center (Informational Item)

Student Success Center Executive Director Sandy Fried will provide members of the committee with an overview of Strategic Vision Goals #5 and #6. As presented to the Board of Governors at its July 2017 meeting, Goal #5 seeks to reduce equity gaps among traditionally underrepresented student groups, with the goal of cutting achievement gaps by 40 percent within 5 years and fulling closing achievement gaps within 10 years. Goal #6 seeks to reduce achievement gaps in regions with the lowest educational attainment of adults, with the goal of closing regional achievement gaps within 10 years.

2. Evaluation of Goals #5 and #6 and Recommendation to Board of Governors (Action Item)

The Strategic Vision Advisory Committee for Goals #5 and #6 will discuss, evaluate and develop a recommendation related to the adoption of Goals #5 and #6. The Committee's recommendation related to the adoption of Goals #5 and #6 will be provided to the full Board of Governors at its regular meeting on September 18 - 19, 2017.
