Impetus for Goals

- Student Success Task Force Recommendations
- SB195 (Liu) signed in September, 2013
 - Goals for all of postsecondary education
- Trailer Bill Language for 2014-15 Budget and subsequent amendment to Education Code
 - Develop system wide goals and locally developed college district goals and targets.

Goals 1, 2 & 3: Student Success Scorecard Rates

➤ Metric Definition

- Completion Rate (Overall, Prepared, Unprepared)
- Remedial Math & English Rates
- CTE (Career Tech Education) Completion Rate.

➤ Goal

To increase the cohort rates by **2.5%** annually within their 6-year follow-up period.








Goal 1. Completion Rate (Unprepared)

Cohort




Goal 1. Completion Rate (Prepared)



Goal 3: Career Technical Education (CTE) Rate

Outcomes for 2013/14 are not available due to changes in the metric definition. An increase of 2.5% is the goal for next year.



Goal 4: Volume of AA/AS Transfer Degrees

➤ Metric Definition


The number of Associate Degrees for Transfer awarded in each academic year

➤ Goal

To increase the number of transfer degrees by **5%** annually for the next 5 years

Goal 5: Completion rates among subgroups

➤ Metric Definition

Using a proportionality (equity) index measure the share of each race/ethnicity subgroup in the outcome group to its share in the overall cohort.

➤ Goal


To increase all underperforming subgroups' proportionality index each year until all subgroups' indices are 0.8 or above.

→ African American


→ American Indian/ Alaska Native

Goal 6: Percent with Education Plans

➤ Metric Definition

Percentage credit & noncredit first-time students enrolled each fall who complete an education plan in the academic year, excluding those who are exempt from a plan.

➤ Goal

To increase the percentage of students who have an education plan each year.



Goal 6. Education Plan

Reporting of this new Student Success data field was optional in 2013/14, so the Education Plan data were entered only for 31% of the students who met the definition.



Goal 7: FTES per Scorecard Outcome

➤ Metric Definition

Number of FTES generated to obtain a “Scorecard outcome”

➤ Goal

To **decrease** the FTES per outcome in each new cohort

→ Lower is better (or more efficient), as it indicates less FTES per outcome



Efficiency Formula


For each Scorecard cohort:

Total FTES generated by the Scorecard cohort during the 6-year period


Total number of outcomes attained by the Scorecard cohort during 6-year period

Goal 8: Participation Rate

➤ Metric Definition


Rate (per 1,000 residents) of the young adult population (18-24) enrolled in community colleges in a given academic year

➤ Goal

To increase the participation rate each year



Goal 8. Participation Rate (Ages 18-24) (per 1,000 population)



Goal 9: Participation Rate among Subgroups

➤ Metric Definition

The proportionality (equity) index calculated for subgroups based on participation rate

→ Measuring whether enrollment by subgroups are proportional to what is observed in the California population

➤ Goal


To maintain the equity index above 0.8 for historically disadvantaged subgroups

→ African American


→ Hispanic
