Anita Moorman reminded everyone that our presenters will be speaking about the monetarization of name, image, and likeness (NIL), and also presented Athletic Associations Policy updates form the National Association of Intercollegiate Athletics (NAIA) and National Collegiate Athlectic Association (NCAA) pertaining to NIL.

Ms. Kristi Dosh – Attorney, Journalist, Sports Business Analyst, SportsBizMiss Enterprises, LLC. Ms. Dosh is a sports business analyst, and expert on licensing, group licensing, and influencer business opportunities for college athletes.

Mr. Blake Lawrence – Co-Founder/CEO, Opendorse. As a football player for the University of Nebraska Mr. Lawrence wasn't able to play after his first year due to injury. He reinvented his expertise and now runs a company that allows student athletes early in their short careers to amortize their athletic skills by building an audience to follow the student athlete. They build on their popularity to increase future opportunities outside of playing college sports.

Ms. Krystal Beachum – Founder, Student Athletes Unite. Ms. Beachum, a former athlete, believes that an athlete should be able to be paid for their NIL. She has created a workshop that teaches students how to start up their own business that will allow them to use their talents to make money, and transition their life after sports in college.

# Item 2.2: Hearing 1, Session 2 – Legal Issues Associated with Maintaining Restrictions on Name, Image, and Likeness Compensation for Community College Athletes (Anita Moorman and Dr. Adam Cocco)

Anita Moorman introduced the afternoon presenters as expert witnesses on the topic of legal issues associated with name, image, and likeness (NIL) compensation for community college athletes.

Prof. Marc Edelman – Attorney and Sport Law Professor, Zicklin School of Business, Baruch College. Mr. Edelman holds four degrees; a Bachelor's in Economics from the Wharton School of Business at the University of Pennsylvania, a Master's degree in Sports Management from the University of Michigan, a Master's in Higher Education Administration from Baruch College, and a law degree from the University of Michigan Law School. His presentation covered past court cases pertaining to free market use of likeness,

name, and image and related them to the current legal landscape regarding NIL for college students, and in particular California community college student athletes.

Prof. Alicia Jessop – Associate Professor and Sport Law Attorney, Pepperdine University, and Journalist. Ms. Jessop has been in the sports law industry for ten years. While interacting with well-known sports persons she realized there was a disparity in compensation for college athletes. SB 206 is a great opportunity for California community colleges support their student athletes.

Mr. Ramogi Huma – Executive Director, National College Players Association. Mr. Huma is an advocate for college athletes, and his non-profit agency co-sponsored SB 206. The agency, in working for student athletic rights advocates, believe it is unfair to exclude only college athletes from the ability to monetarize their name, image and likeness, while all other students on a college campus are allowed to promote themselves, and make money for themselves using their NIL, while a full time, subsidized student.

Called for public comment. No public comments were received.

# ITEM 2.1: HEARING 2, SESSION 1 – ADMINISTRATIVE AND OPERATIONAL ISSUES FOR ATHLETIC ADMINISTRATORS AT CALIFORNIA COMMUNITY COLLEGES (ANITA MOORMAN AND DR. ADAM COCCO)

Dr. Woodyard announced that these presenters were experts in their field and are currently or in the past, part of our California Community College system, or have worked closely with California Community Colleges.

Anita Moorman presented updates pertaining to Name, Image, and Likeness (NIL) – National College Association (NCAA) Policies and ongoing legal cases.

Dr. Christine Worsley – Dean of Kinesiology, Athletics and Dance/Athletic Director, Diablo Valley College.

Dr. Worsely shared her personal and professional knowledge about the affect social media does have on student athletes, and the advantages social media can provide for student athletes today. She mentioned how the "Last Chance" Netflix program on Laney College football illuminated the ease in which students can have many benefits with the tool of social media.

Ms. Kim Duyst – Former Interim Athletics Director/Senior Associate Athletics Director, California State University, Stanislaus

Ms. Duyst contracts with the NCAA and works with them to assist coaches and student athletes. The educational piece regarding NIL compliance is the most important thing for the student who may be transferring. Student well-being is important and that they graduate and or transfer.

Dr. Mitch Campbell – Dean of Kinesiology, Health and Athletics/Athletic Director, Sacramento City College

Dr. Campbell has been with Sacramento City College for 14 years and his number one concern is protecting the infrastructure for the 24,000 California Community College student athletes. The Community Colleges should move slowly and not get involved too soon with the SB 206 legislation. The legislation may not have any negative affect on our colleges, but may diminish our student athletic base if the California Community Colleges moves too quickly into this area... Suggested third party administrator would be key if the System does go forward.

Called for public comment. Ryan McElhinney inserted a comment in the Q&A and also made a verbal public comment via the zoom platform.

#### Action

Dr. Woodyard called for roll after the lunch break to establish a quorum. Nine members were present.

# Item 2.2: Hearing 2, Session 2 – Administrative and Operational Issues for California-Based Athletic Conferences and Governing Associations (Anita Moorman and Dr. Adam Cocco)

Anita Moorman announced that they have scheduled two difference panels to get different perspectives.

Dr. Keith Shackleford – Dean of Kinesiology, Health and Athletics, Irvine Valley College Prof.

Dr. Shackleford encourages the California Community College System to support SB 206 legislation for community college students. The primary responsibility is to students and we should not allow California Community College athletes to be held to a higher level of scrutiny than other athletes who are able to appreciate and benefit SB 206 advantages if they are so interested.

Mr. John Woods – Commissioner, Pacific Coast Athletic Conference.

Mr. Woods's overall presentation spoke to the SB206 legislation as an opportunity for students, especially for those struggling financially. The California Community Colleges need to align with NCAA and National Association of Intercollegiate Athletics (NAIA) to make sure we don't jeopardize the athlete's potential.

Ms. Carol Rivera – Associate Commissioner, Compliance and Internal Operations/SWA, California Collegiate Athletic Association.

Ms. Rivera is currently in the process of preparing our four year schools to enact SB 206.

If colleges within the California community college system were to contract with third-party companies to provide athletes with educational and logistical resources relating to NIL monetization opportunities, what aspects of these resources would need to be considered to assure equal or equitable treatment of male and female athletes?
- 3. From a policy or equity perspective, what types of issues or challenges do you envision that college athletics administrators need to be aware of if their athletes are permitted to receive compensation for the use of their NIL rights? And what, if any, recommendations would you have for administrators charged with implementation of new NIL rules to ensure equitable opportunities?

- 3. As a NCAA Division I program, athletic teams receive transfers from other college athletic divisions including community and junior colleges. How do you envision the transfer and eligibility determination process to function for athletes from outside Division I (such as the CCCAA) who may be seeking entry into a Division I program but have been subjected to different NIL rules at their current university/college?
